This regulatory action is needed in order to establish appropriate and necessary permitting requirements for discharges of wastewater from car wash operations. These discharges are considered to be point sources of pollutants and thus are subject to regulation under the VPDES

permit program. The existing general permit expires on October 15, 2002. The general permit is being reissued in order to continue making it available for car washes after that date. This is a reissuance of an existing regulation, and changes to the regulation are designed to clarify the intent of the regulation. The changes and rational are: (1) the EPA reopener special condition was removed because car wash facilities are not listed as primary industry in accordance with 40 CFR Part 122, Appendix A; (2) the notification levels special condition was added because it is required by the VPDES Permit Regulation, 9 VAC 25-31-200 A for all-manufacturing, commercial, mining and silvicultural dischargers; (3) Part II, K.1.Registration Statement was revised to reflect changes in signature requirements in accordance with the VPDES Permit Regulation. The final text is unchanged from the proposal.

### Statement of Final Agency Action

On May 6, 2002 the State Water Control Board voted unanimously to adopt 9 VAC 25-194-10 et seq., General VPDES Permit Regulation for Car Wash Facilities.
