The Board intends to conduct a general review of its regulations including, but not limited to, the definitions, entry requirements, renewal and reinstatement requirements, and standards of practice and conduct. The proposed amendments will respond to changes in the industry and address concerns brought to the Board by its regulants and the public.

Section 54.1-1102 of the Code of Virginia provides the authority for the Board to promulgate regulations for the licensure of contractors in the Commonwealth. The content of the regulations is pursuant to the Board's discretion, but shall not be in conflict with the purposes of the statutory authority.

General clarifying changes to the regulations. The Board will also review the renewal and reinstatement requirements to address issues related to individual license and certification and trades-related contractors whose qualified individuals no longer have current licenses. In addition, the following are to be reviewed:

18 VAC 50-22-30 (Definitions of specialty services): The Board will determine if changes in the industry warrant the addition, deletion, or modification of specialties.

18 VAC 50-22-40(B), 18 VAC 50-22-50(C), and 18 VAC 50-22-60(C): The Board will explore the possibility of amending the eligibility criteria to require that qualified individuals successfully complete a technical examination in order to demonstrate a minimum level of competency in the applicable specialty or classification.

18 VAC 50-22-260(B): The Board will use statistical data to determine if any changes to these provisions would be appropriate.

Any other changes which may be necessary may also be considered.

Alternatives

There are no alternatives for amendments necessary due to statutory changes. At this time, no alternative has been determined for qualified individuals to demonstrate a minimum level of competency in the applicable specialty or classification, nor has an alternative been determined for addressing issues

related to individual license and certification and trades-related contractors whose qualified individuals no longer hold current licenses. It is likely that many alternatives will be presented during the public comment periods. The Board will consider any and all comments received during the comment periods as to any proposed alternatives.
