Regulatory amendments promulgated in December of 2012 provided that the Qualified Individual of specialties and classifications that did not have individual license or certification requirements, complete a technical examination based on the specialty being applied for on the application. Since this requirement has been in place a number of individuals, who have a specific skill set that is currently covered by a general specialty, have had difficulty in completing the technical examination. After reviewing test data and receiving correspondence and unsolicited comment from many of these individuals, the Board for Contractors has determined that a comprehensive review of the specialties is needed to determine if additional specialties should be added or current specialties amended, in order to provide a less burdensome way for contractors to become licensed, without compromising the protection to the public. The last comprehensive review of the specialties was conducted in 2001.

18 VAC 50-22-20 of the Board for Contractors Regulations defines the scope of practice allowed for each classification. The proposed amendments would clarify the definitions of these specialties to reflect changes in the industry and the Virginia Uniform Statewide Building Code, if applicable.

18 VAC 50-22-30 of the Board for Contractors Regulations defines the scope of practice allowed for each specialty. The proposed amendments would add specific specialties that are currently under a more general specialty in order that contractors that perform those specific specialties are not required to complete an examination in areas in which they do not perform work. The proposed amendments would also clarify the definitions of these specialties to reflect changes in the industry and the Virginia Uniform Statewide Building Code, if applicable.
