This regulatory action will amend the Virginia Hazardous Waste Management Regulations, 9VAC20-60, by clarifying the accumulation area notification requirements under 9VAC20-60-262. The notification requirement applies to large quantity generators; however, as currently drafted, this requirement could be incorrectly applied to Small Quantity Generators as well. In order to clarify this requirement and bring it in line with the original intent of the regulation and the historical application, this section has been revised.

At their meeting on December 13, 2013, the Virginia Waste Management Board approved the following:

- The Board authorized the Department to promulgate the proposed amendment of 9VAC20-60 for public comment using the fast-track process established in § 2.2-4012.1 of the Administrative Process Act for regulations expected to be non-controversial.
- The Board's authorization also constituted its adoption of the regulation at the end of the public comment period provided that (i) no objection to use of the fast-track process is received from 10 or more members of the public, or any member of the applicable standing committee of either house of the General Assembly or the Joint Commission on Administrative Rules, and (ii) the

Department does not find it necessary, based on public comments or for any other reason, to make any changes to the proposal.

• The Board authorized the Department to set an effective date 15 days after close of the public comment period provided (i) the proposal completes the fast-track rulemaking process as provided in § 2.2-4012.1 of the Administrative Process Act and (ii) the Department does not find it necessary to make any changes to the proposal.

This amendment provides clarification to the accumulation area notification requirement in that it only applies to large quantity generators. This was the original intent of the regulation as well as the historical application. This amendment leads to the regulation being in line with the approach while providing clarity to the regulated community since as written it could be applied to Small Quantity Generators, which is not the intent of the regulation.

The proposed amendment is expected to be non-controversial, and therefore using the fast-track process is justified.

The accumulation notification requirements have been clarified to insure proper application to large quantity generators only.
