The Assistant Attorney General has certified that amendments to 18 VAC 85-50-10 et seq. are "necessary to conform to changes in Virginia statutory law or the appropriation act where no agency discretion is involved". Therefore, § 9-6.14:4. (C) (4) is applicable and the amendments are exempt from Article 2 of the Administrative Process Act.
