The amendments to Chapters 20 and 30 are adopted by the Board of Long-Term Care Administrators to facilitate electronic submissions of applications and renewals. Requirements for all documents to be submitted in one package are eliminated to allow the application to be submitted electronically by the applicants and other documents (licensure verification, transcripts, exam scores, etc.) to be sent directly from the source. All references to a renewal application are amended to use the term *renewal form*, since renewal of a license or certificate can now be accomplished on-line by completion of an electronic form and submission of a fee.

The action is exempt and not subject to requirements of the Administrative Process Act in compliance with Chapter 85 of the 2009 Acts of the Assembly.
