The proposed amendment to Section 70 will provide an alternative to the current requirement for tests of English as a written and spoken language. In cooperation with the National Association of Boards of Pharmacy (NABP), the Educational Testing Service (ETS) has revised and combined the Test of English as a Foreign Language (TOEFL) and the Test of Spoken English (TSE) into a four-part internet-based examination, called TOEFL iBT. While ETS will continue to offer TOEFL and TSE upon request until June of 2006, on and after September 24, 2005, the TOEFL iBT is the examination that will routinely be given to graduates of foreign schools of pharmacy. To pass the TOEFL iBT, a graduate will need to achieve a passing score on each of the four parts that test - writing, speaking, listening and reading. A failure on one part will necessitate retaking that part, but not the entire examination.

In the future, the Virginia Board will continue to receive applications from persons who have been practicing in some states who previously passed the TOEFL and TSE examinations, so it must retain those examinations in regulation. However, it must add the TOEFL iBT alternative, as that examination will be the only one available in the coming months.

On September 16, 2005, the Virginia Board of Pharmacy voted to amend 18VAC110-20-10 et seq., Regulations Governing the Practice of Pharmacy, under a fast-track action to add the TOEFL iBT examination to those accepted for applicants who are graduates of foreign schools of pharmacy to provide evidence of written and oral communication in the English language.

Legal basis

Regulations Governing the Practice of Pharmacy, 18VAC110-20-10 et seq., are promulgated under the general authority of Chapter 24 of Title 54.1 of the Code of Virginia. Section 54.1-2400 (6), which provides the Board of Pharmacy the authority to promulgate regulations to administer the regulatory system:

§ 54.1-2400 -General powers and duties of health regulatory boards The general powers and duties of health regulatory boards shall be:

6. To promulgate regulations in accordance with the Administrative Process Act (§ 9-6.14:1 et seq.) which are reasonable and necessary to administer effectively the regulatory system. Such regulations shall not conflict with the purposes and intent of this chapter or of Chapter 1 (§ 54.1-100 et seq.) and Chapter 25 (§ 54.1-2500 et seq.) of this title. ...

The specific statutory authority for the Board of Pharmacy to establish qualifications for applicants for licensure, including tests of written and oral communication in English is found in § 54.1-3312 of the Code of Virginia.

§ 54.1-3312. Qualifications of pharmacist; approved school of pharmacy defined.

- A. In order to be licensed as a pharmacist within the meaning of this chapter, an applicant shall present to the Board satisfactory evidence that he:
- 1. Is at least eighteen years of age;
- 2. *Is of good moral character*;

3. Is a graduate of a school of pharmacy approved by the Board, or a foreign college of pharmacy, if the graduate has satisfactorily completed (i) a college of pharmacy equivalency examination program approved by the Board and (ii) written and oral communication ability tests of the English language approved by the Board;

- 4. Has had a period of practical experience in the United States in accordance with the Board's regulations; however, such requirement shall not exceed twelve months; and
- 5. Has passed the examination prescribed by the Board.
- B. As used in this article, an approved school of pharmacy shall be an institution which meets the minimum standards of the American Council on Pharmaceutical Education and appears on the Council's list of schools of pharmacy as published annually.

Purpose

The proposed regulatory action is necessary to avoid confusion and problems for applicants who will be testing for English proficiency through the Educational Testing Service. Since TOEFL and TSE are being phased out and replaced by TOEFL iBT, the Board's regulation must be amended to accept the combined test. Without an amendment accepting the new TOEFL iBT, the Board may not be able to license graduates of foreign schools of pharmacy after June of 2006 when the current tests will no longer be available. To exclude that group of applicants could reduce the supply of pharmacists in Virginia, thereby reducing the availability of pharmacy services and negatively impacting the health and safety of citizens seeking to have drug histories reviewed, prescription filled and drug counseling provided.

Rationale for using fast track process

Please explain the rationale for using the fast track process in promulgating this regulation. Please note: If an objection to the use of the fast-track process is received within the 60-day public comment period from 10 or more persons, any member of the applicable standing committee of either house of the General Assembly or of the Joint Commission on Administrative Rules, the agency shall (i) file notice of the objection with the Registrar of Regulations for publication in the Virginia Register, and (ii) proceed with the normal promulgation process with the initial publication of the fast-track regulation serving as the Notice of Intended Regulatory Action.

The law requires the Board to test graduates of foreign schools of pharmacy in "written and oral communication ability tests of the English language." Since the tests approved by the NABP and the Virginia Board, currently TOEFL and TSE, are being replaced, it is necessary to update the regulations in keeping with the changes being made. Over the next few months, the testing

service is phasing in the Internet Based TOEFL to replace TOEFL and TSE, so the action to recognize the new combined test is a technical but necessary amendment.

Substance

The proposed amendment to Section 70 will provide as an alternative to the current requirement for tests of English as a written and spoken language the four-part internet-based Test of English as a Foreign Language or TOEFL iBT.

Issues

- 1) There are no disadvantages to the public. The advantage of the tests of written and spoken English is to ensure that licensed pharmacists can adequately communicate with the public and with prescribers. Otherwise, there are significant risks for drug interactions, errors in filling and mistakes in dosing and instructions to patients. Similar drug names can contribute to medical errors, so pharmacists need to be able to clearly understand the orders of a prescriber whether in writing or given orally.
- 2) The primary advantage to the agency is to have a clearly stated regulation that is consistent with the tests currently being offered for graduates of foreign schools of pharmacy. There are no disadvantages.
- 3) There are no other pertinent matters of interest.

Alternatives

Please describe any viable alternatives to the proposal considered and the rationale used by the agency to select the least burdensome or intrusive alternative that meets the essential purpose of the action.

In order to allow the Board to accept the TOEFL iBT, which is the examination graduates will be taking after September 24, 2005, it has amended Guidance Document 110-7, which gives instructions to graduates of foreign schools of pharmacy. The Guidance Document currently lists the regulatory requirement for TOEFL and TSE and gives the scores acceptable to the Board for passage of the tests. In the amended Guidance Document, the Board has deemed the TOEFL iBT as acceptable in lieu of the TOEFL and TSE and has given the scores acceptable for passage on each of the four tests within TOEFL iBT. The passing scores are identical to those recommended by NABP and ETS for these tests.

While the Guidance Document is instructive to applicants, it does not have the enforceability of regulation. Therefore, regulations need to be amended at the earliest possible date for consistency with the English-proficiency tests that will be available in the near future.
