The Board voted at its November meeting to pull changes from 18VAC140-20-37 discussing what types of actions a license type may take from an ongoing action after the OAG requested additional clarification on the changes in the section, including definitions of proposed actions. The Board has decided to file a NOIRA to address those concerns as a separate action. This NOIRA will also revise 18VAC140-20-10 to amend definitions related to those roles and actions.

The purpose of this action is to address a change that came from the 2022 periodic review which the OAG needed more clarification on before they would sign off on the action. In recognition that the Board needed to further address the section, 18VAC140-20-37 was pulled from the Implementation of 2022 Periodic Review Changes action and this NOIRA was initiated to allow the Board the ability to singularly focus on a section that needed more attention.
