This exempt regulatory action updates the following references contained in section 120 of the Chesapeake Bay Preservation Area Designation and Management Regulations (9 VAC 10-20):

1. In 9VAC10-20-120(8), references to the Virginia Stormwater Management Regulations are updated from 4VAC3-20 and 4VAC3-20-71 to 4VAC50-60-10 et seq. Following the passage of Chapter 372 of the 2004 Virginia Acts of Assembly (HB1177), the Virginia Stormwater Management Regulations were revised and recodified into 4VAC50-60-10 et seq. of the Virginia Administrative Code. This change simply recognizes that action.

2. In 9VAC10-20-120(8)(a)(2) and (3), references to Virginia Pollution Discharge Elimination System (VPDES) permits are changed to references to Virginia Stormwater Management Program (VSMP) permits, and references to the Department of Environmental Quality are changed to references to the Virginia Soil and Water Conservation Board. Chapter

372 of the 2004 Virginia Acts of Assembly (House Bill 1177) transferred authority for stormwater permitting from the Department of Environmental Quality and the Virginia Pollutant Discharge Elimination System to the Soil and Water Conservation Board and the Virginia Stormwater Management Program. These changes simply recognize that action.
