By authority granted under Section 3.2-703 of the Code of Virginia, the Commissioner of Agriculture and Consumer Services may extend the areas currently regulated for plant pests. Expansion of 2VAC5-335 et seq., Virginia Emerald Ash Borer Quarantine for Enforcement of the Virginia Pest Law, is now necessary due to the detection of adult emerald ash borers (EAB) in Buchanan, Caroline, Giles, Hanover, Lee, Prince Edward, Stafford, and Warren counties. The amendment will extend the Emerald Ash Borer Quarantine to the entire Commonwealth of Virginia.

The quarantine's regulated articles include ash trees, green (non-heat treated) ash lumber and ash wood products, as well as hardwood firewood. Regulated articles may now move freely within the state.

With the confirmation of the presence of EAB in the counties listed above subsequent to the June 2012 expansion of the EAB quarantine, the agency determined that a statewide quarantine is more appropriate than continuing to extend the quarantine to only those localities with or adjacent to a locality with EAB.

Continually expanding a partial quarantine of the state will place a significant burden on the logging and firewood dealer industries. A partial quarantine of the state would restrict the movement of regulated articles and would require anyone moving regulated articles from or through quarantined localities to obtain a limited permit or certificate from the Department of Agriculture and Consumer Services before doing so.
