Amendments are being proposed to add sections pertaining to the administration of this program. These include sections pertaining to definitions, contract terms, reporting requirements, breach of contract, and waiver provisions. The new sections are comparable in nature and wording to regulations for similar programs and congruent with relevant sections of the *Code of Virginia*.

The Nursing Scholarship Program has been in existence for over twenty years. Although the field of nursing has evolved since that time, the regulations have not kept up with these changes. Amendments are being proposed to ensure that this program is consistent with how the industry has evolved over time. This includes more realistic expectations pertaining to the length of time required to find full time employment upon graduation and changes to the definition of full time employment to be consistent with industry standards.

Section 54.1-3011.1 authorizes the collection of up to \$1 in licensure and license renewal fees for every practical nurse and registered nurse to be deposited in a Nursing Scholarship and Loan Repayment Fund.

Section 54.1-3011.2 establishes the Nursing Scholarship and Loan Repayment Fund for the purpose of financing scholarships for part-time and full-time students enrolled in or accepted for enrollment by nursing programs and gives the Board of Health authority to administer and award such funds.

Section 32.1-122.6.01 authorizes the Board of Health to award scholarships available through the Nursing Scholarship and Loan Repayment Fund.

Sections 23-35.9 through 23-35.13 further define some of the procedures for administering the scholarships including the composition of the Advisory Committee to the State Board of Health, the basis for awards, the requirement for a written contract and contract provisions, provisions for renewal of awards, and definition of how payments should be made.

Purpose

The Virginia Department of Health administers the Nursing Scholarship program, which provides annual nursing scholarships for students enrolled part-time and/or full-time in undergraduate and graduate nursing programs. Selected recipients agree to promptly begin and thereafter engage continuously in nursing practice in the Commonwealth in a region with a critical shortage of nurses for a duration of time based on the total amount of scholarship awarded.

Regulations for other similar scholarship programs are more comprehensive and include sections governing the administration of the program. A more comprehensive set of regulations for the administration of this program is essential for improving the efficacy of the program.

Additionally, the Nursing Scholarship Program has been in existence for over 20 years. Although the field of nursing has evolved since that time, the regulations have not kept up with these changes. Updates to the regulations are needed to ensure their relevance.

The intent of this program is to address the shortage of trained medical professionals in the Commonwealth. The primary advantage to improving the administration of this program would be to increase the availability of adequate, quality medical providers in Virginia.

Substance

Amendments are being proposed to add a section pertaining to the definitions of terms used in the regulations and to provide more clarity about the residency requirement for eligibility. Sections are also being added to provide administrative guidance regarding the terms of service for the contract, the reporting requirements for scholarship recipients, the conditions that would lead to a breach of contract and the consequences for such a breach, and waiver provisions. The waiver provisions allow for flexibility within the program in situations where the recipient and his/her family encounter hardship, disability, or death.

The Nursing Scholarship Program has been in existence for over twenty years. Although the field of nursing has evolved since that time, the regulations have not kept up with these changes. Amendments are being proposed to ensure that this program is consistent with how the industry has evolved over time. This includes more realistic expectations pertaining to the length of time required to find full time employment upon graduation. The recipient of a scholarship currently has 60 days after graduation to report on the status of full-time employment in the state. This time frame is not consistent with the time frame needed to take the licensure exam, receive a license and seek and find full time employment. The proposed amendment would allow the recipient up to 180 days after graduation before being required to report on the status of full-time or part-time employment in the state. Finally, amendments are being proposed to change the definition of full time employment from 40 hours per week to 32 or more hours per week to be consistent with industry standards.

The Virginia Department of Health sees no viable alternative for achieving the purpose of the existing regulation.

This regulation would have a positive, although perhaps indirect, impact on the institution of the family and family stability. Improving the efficacy and efficiency of the administration of this program will ultimately benefit nursing students by helping them with their educational expenses and by helping them save disposable family income. This may lead to increases in potential earnings for the future. Additionally, having a more defined set of guidelines pertaining to this program would give its potential recipients better information to make an informed decision regarding participation in the program. Finally, including waiver provisions in cases of hardship would be beneficial to individuals and their families when they encounter unanticipated hardship situations, such as extended illnesses or disabilities.

12VAC5-510-30		The recipient must agree to engage in full-time (40 hours per week) nursing practice in the Commonwealth	Change the requirement of 40 hours to 32 or more hours to be consistent with the current industry standards. The <i>Code</i> does not reference the number of hours but simply states that the recipient must agree to promptly begin and thereafter engage continuously in nursing practice in the Commonwealth in a region with a critical shortage of nurses for a duration of time based on the total amount of scholarship awarded.
12VAC5-510-30		Full time employment must begin within 60 days of the recipient’s graduation date.	Change the requirement for when employment must begin from 60 days from the date of graduation to 180 days from the date of graduation. This allows the recipient up to 90 days to obtain his/her license and up to an additional 90 days to seek and find

			employment. This change would reflect a much more realistic expectation for a new graduate from a nursing program in today's market.
12VAC5-510-40		No student shall receive scholarships for more than a total of five years.	Change the maximum number of scholarship from five years to four years. There are conflicting sections in the <i>Code of Virginia</i> pertaining to this program. In one section, the maximum number of awards is five (§ 23-35.12). However, in another section, the maximum amount is four (§ 32.1-122.6:01; . This change was made to be ensure congruence with all sections of the <i>Code of Virginia</i> .

12VAC5-510-110	Establishes situations where recipients may be given a waiver of their obligations. Cases include the desire to obtain a graduate degree, hardship, disability, and death. The waiver process allows the program to have some flexibility to reduce the likelihood of adverse impacts of the program on families.		Currently there are no waiver provisions and recipients who encounter hardship and cannot fulfill their obligations automatically go into default status. The program will be more flexible and work with recipients and their families to allow them to defer repayment obligations and/or waive requirements of the contract in the event of unanticipated life events such as disability and death.
