The regulatory action is to update the regulation to incorporate by reference the newest available nationally recognized codes and standards. The standards for amusement devices are controlled by the American Society for Testing and Materials (ASTM).

In conjunction with incorporating the newest available standards into the regulation, the entire regulation will be subject to review and change. This is due to the fact that the ASTM standards constitute the majority of the regulation and the various parts of the regulation must be coordinated with the use of those standards, which necessitates scrutiny of the entire regulation.

This action is exempt from Article 2 of the Administrative Process Act under § 2.2-4406(13) of the Code of Virginia.
