This regulatory action will repeal 22VAC40-80, "General Procedures and Information for Licensure," and establish a comprehensive new regulation, 22VAC40-81. The current regulation was promulgated in 1984 and has undergone amendment several times to incorporate statutory changes. There has not been, however, any comprehensive revision to incorporate changed practices and procedures. Repeal of the existing regulation and adoption of a new regulation is the most efficient and effective way to incorporate all applicable requirements from the Code of Virginia and make the necessary changes to achieve clarity and consistency with current practices and procedures.

The Department of Social Services (Department) needs to update, reorganize, and clarify General Procedures and Information for Licensure to reflect changed practices and procedures that have been implemented in the almost three decades since the regulation was first promulgated. A comprehensive new regulation will provide clear, understandable requirements for licensees and providers and will best protect the health, safety, and welfare of children and adults receiving services. This regulatory action is being taken on advice from the Office of the Attorney General.

The following alternatives were considered: (1) make no changes to the existing regulation and retain the current structure and language; (2) amend the regulation in its current structure and format; and (3) repeal the existing regulation and adopt a new regulation.

Due to the number of changed practices and procedures that have been implemented in the almost three decades since the regulation was first promulgated, it was determined that promulgation of a comprehensive new regulation that has been restructured and re-formatted for clarity and consistency would be in the best interest of all affected by this regulation. A comprehensive new regulation will

provide clear, understandable requirements for licensees and providers and will best protect the health, safety, and welfare of children and adults receiving services.

It plans to establish a regulatory advisory panel (RAP) made up of adult care facility and child welfare agency providers and DOLP staff to provide professional technical assistance and review as the regulation is developed.
