Makes technical corrections to and eliminates some sections from the Regulations Relating to Specifications of the Description to be Obtained By Pawnbrokers of Persons Pawning or Pledging Goods following a full review of the Regulation as mandated by Executive Order 19. This Action amends sections 19VAC30-80-10, 19VAC30-80-20, 19VSC30-80-30, and 19VAC30-80-40. These updates resulted in the reduction of one regulatory mandate, which results in a 25% overall reduction in regulatory mandates contained in this regulation.

Mandate and Impetus

Executive Order 19 (EO-19) and Executive Directive 1 (ED-1) ordered all Executive Branch Agencies of the Commonwealth to review all their regulations with a focus on ensuring agency regulatory requirements are enacted in a manner so as to ensure they meet the needs of the Commonwealth while imposing the least burden and cost on business and citizens of the Commonwealth. As a result of that review these amendments make technical corrections to the Regulations Relating to Specifications of the Description to Be Obtained by Pawnbrokers of Persons Pawning or Pledging Goods

On September 26,2023, the Virginia State Police adopted final amended regulations for 19VAC30-80, Regulations Relating to Specifications of the Description to Be Obtained by Pawnbrokers of Persons Pawning or Pledging Goods. The amendments alter certain sections in 19VAC30-80 as follows:

- **19VAC30-80-10**. Purpose. Revise's purpose statement to reflect compliance with the Code of Virginia as the primary purpose. This had no impact on the mandates.
- **19VAC30-80-20**. Description. This change repealed a section that merely restated the statutory mandate in § 54.1-4009. This change removed one mandate.
- **19VAC30-80-30**. Identifying credentials. This section clarified the requirements for a identify credential. This change did not alter any mandates.
- **19VAC30-80-40.** Electronic submission of required reports. This section was amended to remove redundant language regarding statutory requirements. This change did not impact any mandates.
