[Mandate] VMRC is authorized by § 28.2-201 of the Code of Virginia to promulgate regulations and guidelines necessary to carry out the provisions of Title 28.2, including marine shellfish regulations.

[Impetus] The Commission currently establishes by regulation, Chapter 4 VAC 20-720-10 et seq., "Pertaining to Restrictions on Oyster Harvest", the areas of public oyster harvest, public oyster harvest seasons and oyster resource conservation measures if they wish these to be different from those which are established by §28.2-506 of The Code of Virginia. This regulation supersedes other regulations that in the past had addressed individual harvest areas.
