Peter R. Murchie, D.D.S.
Case No.: 145106 Dr. Murchie appeared with counsel, W. Benjamin Pace, to discuss the allegations set forth in a Notice of the Board dated March 14, 2013. The Committee received statements from Dr. Murchie and Mr. Pace and discussed the allegations with them.

Closed Meeting: Ms. Swain moved that the Committee convene a closed meeting pursuant to § 2.2-3711(A)(27) of the Code of Virginia for the purpose of deliberation to reach a decision in the matter of Peter R. Murchie. Additionally, Ms. Swain moved that Ms. Palmatier and Ms. Toliver attend the closed meeting because their presence in the closed meeting is deemed necessary and their presence will aid the Committee in its deliberations. The motion was seconded and passed.

Reconvene: Ms. Swain moved that the Committee certify that it heard, discussed or considered only public business matters lawfully exempted from open meeting requirements under the Virginia Freedom of Information Act and only such public business matters as were identified in the motion by which the closed meeting was convened. The motion was seconded and passed.

DECISION:
Case No.: 145106 Ms. Toliver reported that the Committee found that while providing treatment to Patient A, Dr. Murchie failed to diagnose periapical radiolucency on tooth #31 on April 25, 2007, and failed to take a periapical radiograph of tooth #31 during a periodic exam

on December 18, 2008.

The Committee also found that Dr. Murchie did not have consent, in writing, from his dental hygienists agreeing to provide services under general supervision; failed to have treatment orders written in the patient records; and failed to have written basic emergency procedures established and in place for his dental hygienists.

The sanctions reported by Ms. Toliver were that Dr. Murchie's license shall be placed on probation for a period of not less than three months subject to terms and conditions that he successfully complete 4 hours of continuing education in risk management; and take and pass the Board's Dental Law Examination.

Ms. Swain moved to adopt the decision of the Committee. The motion was seconded and passed.

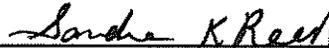

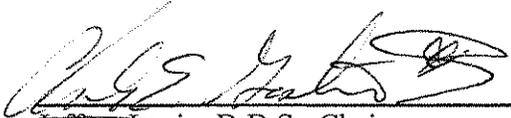
