The purpose of the proposal is to repeal the section authorizing the Professional Boxing and Wrestling Task Force (18 VAC 120-40-60) due to the creation of the Professional Boxing, Wrestling and Martial Arts Advisory Board in statute effective 07/01/07. 2007 Acts of Assembly, Ch. 853.
