<p>Virginia Helicopter EMS Program Update – Tim Perkins:</p>	<p>a. Statistics Report The Medevac Helicopter EMS application (formerly known as WeatherSafe) continues to grow in the amount of data submitted. In terms of weather turndowns, there were 559 entries into the Helicopter EMS system in the second quarter of 2015. 65% of those entries (364 entries) were for inter facility transports, which is close to the average from information from previous quarters. The total number of turndowns is an increase from 480 entries in the second quarter of 2014. This data continues to show dedication to the program itself, but also to maintain safety of Medevac personnel and equipment.</p> <p>Tim sent everyone an email on July 22 as a reminder to check the “Yes” box if there was a previous turndown.</p> <p>b. Duplication of Entries There was no duplication of entries in the second quarter of 2015.</p> <p>c. LZControl Tim has not been in communication with John and Mark of LZControl. There are some funding issues that need to be ironed out before moving forward with the weather reporting part of the system.</p>	<p>Tim will continue to work with LZControl.</p>
<p>Program Announcements:</p>	<p>Susan Smith, Carilion Clinic LifeGuard – Susan reported that LifeGuard will have their annual EMS StarPoints Conference on September 19. Jonathan Godfrey is also scheduled to present on September 15 about Vision Zero and LZ Control. She will send information out. They are also preparing for their CAMTS site visit in the Spring.</p> <p>Dwain Rowe, Wings Air Rescue – Wings is in the process of replacing all four 407s and has already replaced two of them. The other two are scheduled to be replaced by the end of the year. They have hired four new people and have had no problems with the background check process.</p> <p>Chris Shaffer, PHI – Chris reported that PHI has had their OEMS site inspection and everything went well. On October 4 AirCare 4 and Winchester Medical Center will have an education day. AAMS will be doing a safety drive and will raffle off two cars. Auto launch was started in Waynesboro a little over a year and started last month in Harrisonburg. The VCU/VSP integration has been going pretty well.</p> <p>Tim Ryan, U.S. Park Police – No report.</p> <p>Bert Bogue, VCU LifeEvac – Bert agreed that everything is going great with the VCU/VSP partnership.</p> <p>Terry Austin, LifeEvac – LifeEvac has a new lead pilot for LifeEvac 1. They will be hiring a new lead pilot for LifeEvac 3 due to a retirement in November. Terry and Jay attended the UCI Bike Race meeting that will be occurring September 19-27. The 26th and 27th will be big days for air traffic and will set up a UCI Air Ops which will operate on frequency 122.55.</p> <p>Tony Raymond, Wake Forest AirCare – Wake Forest has an open Program Manager position because Holly Mason is no longer there. They have about six applicants so far and the position closes in October.</p> <p>Allan Belcher, Centra Health – Centra Health has lost Joel Randolph, he is taking his career in a different direction. A selection has been made to hire someone from New Mexico with about 30 years of experience. They had a recent incident where there were two helicopters trying to use the same helipad at the same time, they have since developed a call center. The number is 434-200-3132. They will hire one more nurse soon pending salary negotiations.</p> <p>Greg Jones, MedFlight – Bon Secours would like everyone to know that their internal process requires a little lag time and asks that as much advance notice as possible. She told them that she would bring this to the committee today and that the Medevac committee would create a one-page document that would be on the Trauma System OEMS site with a link to read more information about Medevac LZ guidelines. Anita would like volunteers to assist with the creation of the one-page document. Susan volunteered to assist Anita with this. An email will be sent out to the committee for review of the document when completed. This needs to be done quickly.</p> <p>Bert stated that VCU LifeEvac has started looking more at rollover flights and are reaching out to community partners. As far as the QA process internally, they are looking at the times, because they are seeing some delays. They want to ensure that they are doing the right thing for the patient.</p> <p>Terry spoke about the frequent drone activity. Others voiced their concerns as well.</p> <p>Susan said that HealthNet 5 was intentionally lazed by someone in the West Virginia area. This is occurring about every three months.</p> <p>Chris reported that Martha Jefferson Hospital is starting to do interventional neurology, but they do not have a helipad. They are looking at building a ground pad. For now Rockingham will transport patients to Martha Jefferson. Chris also reminded everyone about the East Coast Helicopter Ops Conference in Virginia Beach in September.</p> <p>Tim reminded everyone to let him know if they will need lodging for the meeting at symposium.
