



# VOSH PROGRAM DIRECTIVE: 12-420

# <u>ISSUED</u>: June 15, 1997

# **<u>SUBJECT</u>**: Special Provisions for Air Contaminants, § 1910.19; Amendment

# A. <u>Purpose</u>.

This directive transmits to field personnel the above-referenced amended standard.

This Program Directive is an internal guideline, not a statutory or regulatory rule, and is intended to provide instructions to VOSH personnel regarding internal operation of the Virginia Occupational Safety and Health Program and is solely for the benefit of the program. This document is not subject to the Virginia Register Act or the Administrative Process Act; it does not have general application and is not being enforced as having the force of law.

# B. <u>Scope</u>.

This directive applies to all VOSH personnel, and specifically to Occupational Health Compliance and Cooperative Programs personnel.

# E. <u>Action</u>.

The Deputy Commissioner, Directors and Managers shall assure that field personnel understand and comply with the provisions of this standard.

# H. <u>Background</u>.

On November 4, 1996, federal OSHA published the new final rule for Occupational Exposure to 1,3-Butadiene (BD), § 1910.1051, which reduced the permissible exposure limit (PEL) from concentrations up to 1,000 parts 1,3-Butadiene per million parts of air (1,000) as an eight-hour time-weighted average (TWA) to an 8-hour TWA of 1 ppm and a short term exposure limit (STEL) of 5 ppm for 15 minutes. The amendment to Special Provisions for Air Contaminants, § 1910.19, resulted from the promulgation of the BD standard.

On January 10, 1997, federal OSHA published final rules for the Occupational Exposure to Methylene Chloride (MC): General Industry, § 1910.1052, Shipyard Employment, § 1915.1052 and Construction, § 1926.1052. These final rules reduced the existing eight-hour time-weighted average (TWA) permissible exposure limits (PEL), deleted the existing ceiling limit concentration, and reduced the existing short-term exposure limit. The amendment to Special Provisions for Air Contaminants, § 1910.19, resulted from the promulgation of the MC standard.

# I. <u>Summary</u>.

In the first amendment, paragraph (l) of the Special Provisions for Air Contaminants, § 1910.19, was amended to reference the new final rule, Occupational Exposure to 1,3-Butadiene, § 1910.1051. Paragraph (l) explains that § 1910.1051 applies to the exposure of every employee to 1,3-Butadiene in construction work, shipyard employment and longshoring and marine terminal.

In the second amendment, paragraph (m) was added to § 1910.19. This new paragraph states that § 1910.1052, Occupational Exposure to Methylene Chloride (MC), applies to the exposure of every employee and place of employment covered by § 1910.16, Longshoring and marine terminals, in lieu of any different standard on exposure to MC which would otherwise be applicable by virtue of that section when it si not present in sealed, intact containers.
