Code of Virginia § 54.1-201.5 gives authority to the Board which states, in part, that the Board has the power and duty "To promulgate regulations in accordance with the Administrative Process Act (§ 2.2-4000 et seq.) necessary to assure continued competency, to prevent deceptive or misleading practices by practitioners and to effectively administer the regulatory system administered by the regulatory board." § 54.1-1802 provides the Director of the Department of Professional and Occupational Regulation "promulgate regulations necessary to carry out the provisions of [Chapter 18 of Title 54.1 of the Code of Virginia] and Chapter 1 (§ 54.1-100 et seq.)."

18 VAC 120-30-30 provides the authority for the Director of the Department of Professional and Occupational Regulation to appoint a Board to advise the Department on any matters relating to the practice or licensure of polygraph examiners.

The regulation establishes the education, examination, and experience requirements to become a Virginia registered Polygraph Examiner Intern and a licensed Polygraph Examiner. The regulation requirements provide minimum competency standards to provide necessary public protection. The regulation is clearly written and understandable.

1) Code of Virginia §§ 54.1-201.5 and 54.1-1802 mandates the Director of the Department of Professional and Occupational Regulation authority to promulgate regulations. The continued need for the regulation is established in statute. Repeal of the regulation would remove the current public protections provided by the regulation. The regulation does not have an adverse economic impact on small businesses nor individual licensure or registration. Rather, the regulation allows individuals who meet specific minimum competencies to become licensed or obtain intern registration in Virginia.

- 3) The regulation is clearly written and is easily understandable.
- 4) The regulation does not overlap, duplicate or conflict with federal or state law or regulation.
- 5) The most recent evaluation occurred in 2005 which resulted in amendments to increase fees in order to ensure that the Polygraph Examiners Advisory Board remains in compliance with § 54.1-113 of the Code of Virginia. The fee amendment went into effect August 1, 2007. Currently, a proposed amendment to the regulation is pending executive branch review. The proposed amendments include a change in the size of the Polygraph Examiners Advisory Board, allows an applicant to take portions of the examination at different dates within a one year period, clarifies renewal and reinstatement requirements and provides for a procedure to be used in the event that an examiner supervising an intern is unable to provide verification of experience. No changes, including changes in technology and economic conditions, have been identified that would affect licensed individuals seeking registration as a polygraph examiner intern or licensure as a polygraph examiner.

The Director, for the reasons stated in this section, determined that the regulation should not be amended or repealed, but should be retained in its current form.
