Sections 3.2-5101 and 3.2-5121 of the Code of Virginia provide the legal basis for this regulation and authorize the Board of Agriculture and Consumer Services to adopt regulations, as needed, to ensure that ground beef products contain no more than the maximum allowable fat content and that ground beef products marketed in Virginia are accurately represented to the consumer.

Alternatives

Please describe all viable alternatives for achieving the purpose of the existing regulation that have been considered as part of the periodic review process. A possible alternative is to utilize the Virginia Food Laws as the only basis for regulating multiple food commodities, products, and processes. These laws, however, are very general and do not contain the detail of regulatory requirements that are needed for regulating the tolerances and prohibitions for ground beef. Ensuring the safety and accurate representation of ground beef is necessary in order to protect food safety and to reduce the incidents of food borne illness.

This regulation is necessary to protect the public's health, safety, and welfare as it pertains to ground beef, including its labeling and fat declaration requirements. This regulation ensures that consumers purchasing a ground beef product are offered a product that contains no more than the maximum allowable fat content and ensures that the ground beef products are accurately represented to the consumer. The regulation is clearly written and easy to understand.

This regulation is still needed because it is still necessary to ensure that ground beef products are produced according to and meet minimum acceptable standards relative to product formulation and saturated fat content. It also ensures that consumers are duly informed via product labeling and placard displays regarding the fat content of ground beef products and allows consumers to make optimal health choices regarding the level of saturated fat consumed when ground beef products are purchased.

Without this regulation, it will be difficult to find other means by which to ensure that ground beef products meet acceptable standards. Federal regulations also exist which mandate a maximum fat content of 30 percent in ground beef products. However, these regulations are primarily enforced and policed at meat processing facilities. The subject regulations are typically enforced and apply to ground beef products formulated and/or sold at retail food stores and create specific production standards applicable to retail environments. Since the last time this regulation was evaluated, there have not been significant changes in technology, economic conditions, or other factors that would impact this regulation. This regulation was promulgated with due concerns for industry and has minimal impact on small businesses. It is recommended that the regulation remain in place without modification. There have been no complaints received relative to this regulation.

Family impact

It is the agency's goal to ensure that food products produced and sold in the Commonwealth meet acceptable standards and are properly labeled. Furthermore, another primary objective of the agency is to ensure that consumers and families are afforded the opportunity to make informed and healthy food choices. Limiting the consumption of saturated fat in the diet (from ground beef and similar products) will likely have a direct impact on families by minimizing both acute and chronic health conditions such as cardiovascular disease and hypertension. This has a direct impact on the family and family stability by improving family health, reducing medical care costs, and reducing mental, physical, and emotional pain and suffering.
