Section 3.2-109 of the Code of Virginia (Code) establishes the Board of Agriculture and Consumer Services (Board) as a policy board and authorizes the Board to adopt regulations in accordance with the provisions of Title 3.2 of the Code. Section 3.2-703 of the Code authorizes the Board to quarantine the Commonwealth or any portion thereof when it determines that such action is necessary to prevent or retard the spread of a pest into, within, or from the Commonwealth.

Alternatives

Thousand Cankers Disease (TCD) is a complex that is carried by the Walnut Twig Beetle and impacts walnut trees. If a Walnut Twig Beetle attacks a walnut tree, it causes the tree to become infected with TCD, which eventually may kill the tree. Ongoing research is being conducted to determine the potential for mass walnut tree death caused by TCD and spread of the disease to uninfested areas either by natural means or through the movement of infested articles such as walnut plants or plant parts, including nursery stock, budwood, green lumber, firewood, stumps, branches, mulch, and chips. The quarantine restricts the movement of these plants and plant parts in order to slow the spread of this disease. The agency determined that these requirements are not unnecessarily burdensome and provide an important means to prevent the spread of TCD. Therefore, alternatives to this regulation were rejected.

This regulation was put in place to help prevent the artificial spread of TCD to uninfested areas of the Commonwealth by regulating the movement of the articles that are capable of transporting the disease. Spread of this disease by the Walnut Twig Beetle, which is the vector for this disease, could impact Virginia's walnut tree population by infecting and ultimately killing walnut trees. The agency has determined that this regulation should be retained in order to provide protection against spread of this potentially harmful disease of walnuts.

There have been no complaints from the public concerning the regulation. This regulation does not overlap, duplicate, or conflict with federal or state law or regulations. The agency has determined that no changes have occurred in the area affected by this regulation since the last periodic review that would make it necessary to amend or repeal the regulation. The agency has determined that that current version of this regulation is consistent with current industry practices and is the least burdensome and least intrusive alternative.
