The promulgating agency is the Board for Contractors ("the Board").

Code of Virginia § 54.1-201(A)(1) gives the Board the power and duty to “establish the qualifications of applicants for certification or licensure by any such board, provided that all qualifications shall be necessary to ensure either competence or integrity to engage in such profession or occupation.”

Code of Virginia § 54.1-201(A)(5) gives authority to the Board to promulgate regulations. It states, in part, that the Board has the power and duty “[t]o promulgate regulations in accordance with the Administrative Process Act (§ 2.2-4000 et seq.) necessary to assure continued competency, to prevent deceptive or misleading practices by practitioners and to effectively administer the regulatory system administered by the regulatory board.”

No alternatives were considered as part of this periodic review. The regulation enables the Board to fulfill the statutory requirements established in Chapters 2 and 11 of Title 54.1 of the Code of Virginia. Further, the regulation is necessary to ensure that the Board’s statutory requirements are executed in the least burdensome and most efficient and cost-effective manner possible while protecting the health, safety, and welfare of the citizens of Virginia.

It’s indicated the current regulations have served the Commonwealth of Virginia for this long, the Board should allow them to stand as they are.	The Board thanks the commenter.  The Board elects to retain the regulation in its current form without amendment at this time. The decision to retain a regulation in its current form does not prevent the Board from initiating action to review or amend the regulation in the future.

The regulation meets the criteria set forth in the Office of Regulatory Management procedures. The regulation contains the requirements for obtaining a license, certification, or training provider/course approval, renewal and reinstatement of licenses, standards of practice and conduct, and prelicense

education to ensure competence and integrity of all licensees and to administer the regulatory program in accordance with Chapters 2 and 11 of Title 54.1 of the Code of Virginia. The regulation is necessary for the protection of public health, safety, and welfare and is clearly written and understandable.

On September 19, 2023, the Board voted to retain the regulation “as is” without any change, as explained further in the “Small Business Impact” section. In accordance with the Governor’s Executive Directive Number One (2022), the Board is currently undertaking a separate action to perform a comprehensive line-by-line review of this regulation.

Code of Virginia §§ 54.1-201(A)(1) and 54.1-201(A)(5) mandate the Board promulgate regulations. The continued need for the regulation is established in statute. Repeal of the regulation would remove the current public protections provided by the regulation. The Board provides protection to the safety and welfare of the citizens of the Commonwealth by ensuring that only those individuals that meet specific criteria set forth in the statutes and regulations are eligible to receive contractor license. The Board is also tasked with ensuring that its regulants meet standards of practice that are set forth in the regulations.

One comment was received during the public comment period. The commenter suggested that the regulations should remain the same as the existing regulations have served the Commonwealth well. The Board elected to retain the regulation in its current form, with the acknowledgement that such decision does not prevent the Board from initiating action to review or amend the regulation in the future.

The Individual License and Certification Regulations are clearly written, easily understandable and, and do not overlap, duplicate, or conflict with federal or state law or regulation.

The most recent periodic review occurred in 2019. The Board is currently conducting a comprehensive review of the regulation in accordance with Executive Directive Number One (2022).
