This regulation establishes the reporting requirements for contagious and infectious diseases of livestock and poultry, by any person practicing veterinary medicine, any person or firm operating a laboratory for the diagnosis of livestock or poultry diseases, and any other reporting entity designated by the State Veterinarian within the Commonwealth of Virginia.

Sections 3.1-724 and 3.1-726 of the Code of Virginia (1950), as amended, require the State Board of Agriculture and Consumer Services, the State Veterinarian, and all other veterinarians within the Commonwealth to use their best efforts to protect the domestic animals and poultry from disease. Consequently, the State Board of Agriculture and Consumer Services and the State Veterinarian shall establish rules and regulations to establish livestock and poultry disease surveillance, control, and eradication programs to prevent the possible spread of diseases.

The specific and measurable goals of the regulation are:

1. The protection of the public's health and welfare with the least possible cost and intrusiveness

to the citizens of the Commonwealth.

2. The prevention of contagious and infectious diseases into animal populations in the Commonwealth by reporting suspected or confirmed diseases within 24 hours (Schedule A) or the first of each month (Schedule B).

The effectiveness of the regulation in achieving these goals is reflected, in part, in the freedom from most if not all of the diseases on Schedule A and Schedule B. that may affect both animals and humans in Virginia. The Commonwealth has prevented the incursion of many of these diseases having a major impact on the livestock and poultry industries because of the effectiveness of the disease reporting regulation. Not only has the regulation effectively protected the public's health and welfare, but it has prevented death losses and decreased production of livestock and poultry. This action translates into a consistent source of animal protein that is affordable and of good quality for Virginia consumers. Preventing and controlling infectious and contagious diseases within an animal population is dependent upon a successful disease reporting system that quickly identifies disease problems in the animal population. Because healthy animals tend to bring better prices and are therefore more valuable when marketed, it is beneficial to Virginia's livestock producers that reporting entities promptly report these diseases to provide the best opportunity to control or eradicate them if possible. Also, healthy animals pose less risk to the health of the human population since a number of diseases of livestock and poultry affect man.

The regulation is clearly written and easily understandable by the individuals and entities affected.

#### **Alternatives**
