- 2. Ensure that there is adequate space and instructional technology and equipment for simulating client care [18VAC 90-25-50.D.4 & 5].

And the following suggestions for improving the program:

- 1. Consider employing an additional RN or LPN to assist in the skills lab and provide clinical supervision;
- 2. Expand the skills lab to include at least three beds to adequately accommodate the number of students in the program; and
- 3. Develop and implement a plan to increase the pass-rate on the skills portion of the nurse aide exam (NNAAP) to above 80%; currently the pass-rate is 33% on the skills portion of the exam.
