3. Division Update.

Mr. Harvey Powers, Division Director, DCJS Division of Law Enforcement, provided updates on VLEPSC and the addition of Todd Clingenpeel as Accreditation Center Manager; Compulsory Minimum Training Standards and Performance Outcomes for Law Enforcement Officers which were recently passed continue to go through the regulatory process; TRACER has been operational for about 5 months and looking to what TRACER can do in the future; decertification cases are increasing in numbers and along with that are an overwhelming amount of FOIA requests as well; DCJS participation in Violent Crimes Conference, Virginia Academy Director's Conference, IADLEST (International Association of Directors of Law Enforcement Standards and Training) Conference); budget although not finalized appears to have a lot of resources for Law-Enforcement.
