Mr. Erb seconded the motion which was unanimously approved by the following members: Rice, Erb, Hastings, Reed and White.

The Board agreed without dissent that the information contained in the following applications did not establish that the applicants met the entry requirements of the Code of Virginia and the Board for Geology Regulations:

Daniel Vellone's application by reciprocity based on his Geology License from Tennessee did not document that Mr. Vellone had completed the required number of geological science courses that would lead to a major in geology, as provided for in § 54.1-1403 B 2 of the Code of Virginia. The Board carefully considered a letter dated April 1, 2005 from Frank S. Spear, Professor and Chair, Rensselaer Polytechnic Institute, concerning the coursework completed by Mr. Vellone and concluded that Mr. Vellone has only had exposure to aspects of the required geological sciences courses that would lead to a major in Geology. The Board also considered whether Mr. Vellone was eligible to sit for the Board's examination and determined that he did not document that he is eligible to sit for the examination.

William Randall's application for reinstatement did not establish that he has passed a state geology examination. Mr. Randall may submit a complete application to determine whether he meets the current regulation's standards to sit for the examination.

Jean Swan-Ambrose's application for reinstatement did not establish that she had passed a state geology examination. Ms. Swan-Ambrose may submit a complete application to determine whether she meets the current regulation's standards to sit for the examination.
