#### CEMETERY BOARD MEETING

#### **MINUTES**

#### September 5, 2018

The Cemetery Board met on September 5, 2018, at the Department of Professional and Occupational Regulation (DPOR), 9960 Mayland Drive, Richmond, Virginia. following members were present:

Randolph Minter called the meeting to order at 10:00 A.M.

Call to Order

A motion was made by Mr. Doherty and seconded by Mr. Meadows to Agenda approve the agenda. The motion passed unanimously. Members voting "Yes" were Butler, Doherty, Dudley, Eisenman, Lyttle, Meadows and Minter.

A motion was made by Mr. Doherty and seconded by Mr. Dudley to Minutes approve the February 7, 2018, Board Meeting minutes. The motion passed unanimously. Members voting "Yes" were Butler, Doherty, Dudley, Eisenman, Lyttle, Meadows and Minter.

Susan Mini, President of the Virginia Cemetery Association (VCA), Public Comment addressed the Board to introduce herself and inform them of her position with VCA for the next two year term. No action was taken by the Board.
