Leah Ann Smith addressed the Board on issues related to her application to obtain a Virginia cosmetologist license by endorsement from West Virginia, after it was determined by staff that Ms. Smith did not meet the qualifications for a license by endorsement. Ms. Smith provided Board staff with a copy of her remarks.

Mr. Jesse Smith, licensed tattooer and owner of Loose Screw Tattoo, addressed the Board on several topics related to tattooing, including school and apprenticeship curriculum hours, extended temporary licenses for guest tattooers, license qualification for out-of-country tattooers, and a wish to meet with staff to participate in the review and update of Tattoo Regulations.

Mr. Emmanuel Gayot, Sr., owner and Barber Teacher at Edify Barber Academy of Richmond, questioned the Board on why the barber examination includes testing on shaving, while the cosmetologist examination does not, and cosmetologists are permitted to shave. Mr. Gayot was advised that the Board could not respond to his inquiry during the meeting, and it was suggested that he

Master Barber **Board Guidance**

Mr. Kirschner directed the Board to a proposed Guidance Document addressing Master Barber applicants who have completed training equivalent to the Master Barber curriculum (Addendum 2). The Board reviewed the proposed Guidance Document.

Upon a motion by Mr. Jones and seconded by Ms. LaPierre, the Board voted to adopt the Master Barber Guidance Document.

The members voting 'yes' were Mr. Hill, Mr. Jones, Ms. LaPierre, Ms. Mace, Mr. Quesenberry, Mr. Roberts, and Mr. Williams. There were no negative votes. The motion passed unanimously.

Mr. Kirschner directed the Board to a memo to the Board, dated July 27, 2018, regarding the correction of several typographical errors in the revised Esthetics Regulations that became effective on February 1, 2017 (Addendum 3). He advised the Board consider making the recommended corrections to the regulations.
