#### Minutes from the last meeting

Chairman Coleman asked the members if they reviewed the minutes from January 15, meeting. Mr. Seibert asked that Gary Teter name be deleted from the last meeting; he is not a member of this committee. Mr. Coleman called for a motion to approve the minutes with the necessary correction, deleting Mr. Teter from December minutes. A motions made by Mr. Seibert seconded Mr. Sawyers, and the minutes was adopted unanimously.

## **Executive Director Report:**

Mr. Foster stated that this is a communication committee meeting and the proposed regulations will not be discussed in this meeting.

Mr. Foster was asked to come up with ways to get the word out to the towers that had not responded to the previous mailing. He stated that the board has sent out fifteen-hundred news letters, and contact cards. The boards email address is listed on both mailing so that towers can respond electronically. The State Police and Sheriff Departments were given contact cards to pass out in their jurisdictions. There were a total of three-thousands cards mailed out and only seven hundred and thirty has returned to the board. Chairman Hodge asks that the committee find a way to reach the towers that have not responded.

Mr. Foster had a conversation with Lieutenant Curtis Hardison in regards to getting the word out. He suggested that the Mr. Foster reach out to all the inspection stations in the state. Lieutenant Hardison forward a list of over five –thousands inspection station, and the board will come up with a flyer or mailing that the stations can pass out to the towers.

Mr. Foster asked that the committee come up with a logo that can be placed on the items that the board will be sending out.
