Examination Statistics Report

Mr. Saunders advised the Board he will begin 2018 WWW CPE audits in the near future and will have an update at the Board's next Report meeting scheduled for April 19, 2018.

WWW CPE Audit

Mr. Saunders presented the Board with a training course application from Heyward Incorporated of Virginia for a course titled Regional Pump School. After discussion, Mr. Fore moved to accept the Education and Training Committee's recommendation and approve the course application for a total of 0.63 training credits, retroactive to December 7, 2017. Mr. Staples seconded the motion which was unanimously approved by: Brockwell, Evans, Ewing, Fore, Lentz, Pruett, Staples, and Wadkins.

Update on **Education** and **Training Committee**

Mr. Saunders presented the Board with a training course application from Virginia Section American Water Works Association for a course titled Cross Connection Devices: Inspection, Maintenance & Testing. After discussion, Mr. Fore moved to accept the Education and Training Committee's recommendation and approve the course application for a total of 1.6 training credits, retroactive to November 14, 2017. Ms. Pruett seconded the motion which was unanimously approved by: Brockwell, Evans, Ewing, Fore, Lentz, Pruett, Staples, and Wadkins.

The Board agreed by consensus to move forward with the agenda and discuss 2017 ABC exam implementation later in the meeting.

Discussion of 2017 **ABC Exam Implementation**

Ms. Henshaw and Mr. Staples asked the Board to consider the **Discussion of**

applicability of industrial water treatment plant experience to waterworks and wastewater works license requirements. After discussion, the Board agreed by consensus that staff will consult counsel to clarify the Board's authority to allow industrial water plant experience to fulfill experience requirements for a waterworks or wastewater works license. Further, the Board agreed by consensus to continue the discussion on the topic when or if a representative of the industrial water plant industry makes an inquiry to the Board regarding the applicability of industrial water treatment plant experience to waterworks and wastewater works licensing.

Applicability of **Industrial Water Treatment Plant** Experience to Waterworks and Wastewater Works Operator Licensing

Ms. Henshaw presented to the Board a staff memo dated September 1, 2011, related to the guidance document on the installation of non-discharging onsite sewage system which was revised by the Board at its October 26, 2017 meeting. The Board reviewed the memo for informational purposes.

Discussion of OSSP **Guidance Document** on Installation of Non-discharging **Onsite Sewage** Systems

Ms. Henshaw and Ms. Webster advised the Board of the findings of the Subject Matter Expert (SME) Committee review of the ABC standardized exam for Class 1-4 waterworks and wastewater works operator licensee applicants. The Board staff shared feedback from the SMEs regarding the exam, as well as additional information staff obtained from PSI and ABC regarding the defensibility and validity of the exam. After discussion, Ms. Lentz moved to authorize staff to move forward with the implementation of the 2017 ABC standardized exam. After further discussion, Mr. Wadkins seconded the motion which was unanimously approved by: Brockwell, Evans, Ewing, Fore, Lentz, Pruett, Staples, and Wadkins.

Ms. Henshaw and Mr. Saunders updated the Board on recent and Update on Outreach upcoming outreach opportunities.
