Mr. Vanderland moved that the Board accept the Consent Order for Count 1 that Mr. Rodriguez was in violation of 18 VAC 160-20-109.A.3 and that no monetary penalty is imposed, but requires \$150 payment for Board costs. The respondent further agrees to suspension of his license until he has provided proof of successful completion of eight CPE contact hours and to one year probation of his Class V Operator license. Mr. Davis seconded the motion which was approved by the following members: Leininger, Walker, Kleene, Davis and Vanderland. Mr. Cawthron recused himself and did not participate in any discussion or vote.

In the matter of **File Number 2007-00619, Gene Edward Collins**, the Board reviewed the record which consisted of the application file, transcript and exhibits from the IFF and the presiding officer's summary and recommendation. Upon a motion by Mr. Walker and seconded by Mr. Vanderland, the Board adopted the summary and recommendation and approved the application for Class II Waterworks Operator license for Gene Edward Collins. The motion was unanimously approved by the following members: Leininger, Walker, Cawthron, Kleene, Davis and Vanderland.

In the matter of File Number 2007-00867, Reco Marcell Johns, Sr., the Board reviewed the record which consisted of the application file, transcript and exhibits from the IFF and the presiding officer's summary and recommendation. Dr. Kleene moved that the Board accept the summary and recommendation and approve the application for Wastewater Works III Operator license for Reco Marcell Johns, Sr. Mr. Walker seconded the motion which was unanimously approved by the following members: Leininger, Walker, Cawthron, Kleene, Davis and Vanderland.
