CALL TO ORDER

Mr. Walton called the meeting to order at 10:03 a.m. and asked the Board members and staff to introduce themselves.

With nine members present at the meeting, a quorum was established.

Mr. Walton read the mission of the Board, which is also the mission of the Department of Health Professions.

Mr. Walton provided reminders to the Board members and audience regarding microphones, sign in sheets, computer agenda materials, attendance for continuing education requirements, and breaks.

Ms. Tillman Wolf then read the emergency egress instructions.

ORDERING OF THE AGENDA

Mr. Walton requested to receive public comment prior to the approval of the minutes.

Upon a *MOTION* by Ms. Steele and properly seconded by Mr. Omps, the Board voted to accept the agenda as amended. The motion passed unanimously.

PUBLIC COMMENT

The Board received public comment from Ross Miller. Mr. Miller requested the Board to revise the October 16, 2018 full Board meeting minutes regarding the Board's executive session in regards to third party casket sales. He requested the Board to clarify the statement to specify that the Board could not regulate unlicensed individuals. Mr. Miller also addressed the complaint process through the Department of Health Professions and requested a clearer process and guidance on how the Board takes action.

APPROVAL OF MINTUES

Upon a *MOTION* by Mr. Nelsen, and properly seconded by Mr. Slusser, the Board voted to accept the October 16, 2018 Board meeting minutes, the October 16, 2018 Formal Hearing meeting minutes, the November 1, 2018 Regulatory Advisory Panel on Preneed Funeral Planning meeting minutes, and the December 6, 2018 Ad Hoc Committee on Internships meeting minutes as written. The motion passed unanimously.

AGENCY REPORT

Dr. Brown and Dr. Allison-Bryan were not present at the time of the Agency Report as they were attending the General Assembly. Ms. Yeatts stated that there was no new information to provide.

STAFF REPORTS

Executive Director's Report -Corie E. Tillman Wolf

Ms. Tillman Wolf presented the Expenditure and Revenue Summary as of December 31, 2018.

Ms. Tillman Wolf reported that The Conference is holding their 115th Annual Meeting in San Diego, CA from February 27-28, 2019. She also reported that the 2018 Continuing Education Review was included in the agenda packet for review.

Ms. Tillman Wolf provided an overview of items that staff will be working on in 2019 to include developing online applications, implementing a streamlined electronic process for inspections, providing support for the periodic review of regulations, updating Board guidance documents and MOUs, reviewing and updating examination content, facilitating communication to licensees about the EDRS, and increasing overall licensee communications.

Ms. Tillman Wolf presented the Inspections Report from 2018. She stated that 149 inspections were conducted for main establishments, branch establishments and crematories. She noted the following deficiency rates:

- Crematories 96.4% with no deficiencies
- Branches 61% with no deficiencies
- Main Establishments 38.7% with no deficiencies

Ms. Tillman Wolf noted the most common deficiencies for 2018 as follows:

Mr. Nelsen reported that the meeting minutes from the Ad Hoc Committee on Internships were included in the agenda packet for review. Mr. Nelsen reviewed the recommendations from the Ad Hoc Committee on Internships for the Board's consideration. Mr. Nelsen requested additional discussion from the Board on the number of internship hours at the April 2019 Board meeting pending additional research of other jurisdictions.

Mr. Jones requested clarification on the issue of identification of interns.

Dr. Allison-Bryan reported that she and Dr. Brown had been participating in the General Assembly and reported that she was impressed with the spirit of the cooperation of everyone involved to ensure the health and safety of the public.

Ms. Yeatts provided a brief overview of regulatory actions pending by the Board.

Legislative Report

Ms. Yeatts provided an overview of the bills that could possibly impact the Board at the 2019 General Assembly.

Mr. Omps and Mr. Nelsen requested additional information in regards to House Bill 1828: Legislation Regarding Casket Sales. Ms. Barrett stated that the General Assembly was responsible for drafting and passing bills and the Board would have more information following the conclusion of the General Assembly. Ms. Yeatts stated that DHP did not have a position on the bill at that time.

Ms. Yeatts provided a review of Senate Bill 1300: Funeral Establishments; Full Time Manager Required. Board members discussed concerns regarding the operation of two establishments by a single full-time funeral service licensee or funeral director if the combined average number of funeral calls at the two establishments is up to an average of 135 calls per year and the distance between the two establishments is up to 50 miles.

BREAK

The Board took a 10-minute break at 11:25 a.m. The Board reconvened at 11:39 a.m.

Upon a *MOTION* by Mr. Nelsen, which was properly seconded by Mr. Omps, the Board requested communication to the Governor's Office that the Board have the opportunity to study the effects of Senate Bill 1300 and to report back to the General Assembly for the 2020 Session, or in the alternative, that an amendment be sought to require a fourth component to the hardship waiver – that the Manager of Record and facilities have current, unrestricted licenses at the time of the application for waiver. The motion passed unanimously.

Discussion of Recommendations from the Regulatory Advisory Panel – Preneed Funeral Planning

Ms. Yeatts reviewed the recommendations from the Regulatory Advisory Panel and requested the Board to discuss the recommendations for consideration.

Upon a *MOTION* by Mr. Nelsen, which was properly seconded by Ms. Mimms, the Board moved to adopt the NOIRA for the Regulations for Preneed Funeral Planning (18VAC65-30-10 et seq.). The motion passed unanimously.

Discussion of Recommendations from the Ad Hoc Committee on Internships

Ms. Yeatts reviewed the recommendations from the Ad Hoc Committee on Internships and requested the Board to discuss the recommendations for consideration.

Upon a *MOTION* by Mr. Slusser, which was properly seconded by Mr. Omps, the Board moved to adopt the NOIRA for the Regulations for the Funeral Service Internship Program (18VAC65-40-10 et seq.) and to withdraw the current notice and incorporate the issues into the new NOIRA. The motion passed unanimously.

Review of Guidance Documents for Re-adoption

Ms. Yeatts reviewed Guidance Documents 65-4 and 65-15 with the Board and the need for Guidance Documents to be reviewed every four years.

Board members discussed a revision to Guidance Document 65-15 to clarify that the Board will grant no more than two one-year extensions to an intern.

Upon a *MOTION* by Mr. Nelsen, and properly seconded by Mr. Omps, the Board voted to readopt Guidance Documents 65-4 and to revise Guidance Document 65-15. The motion passed unanimously.

Repeal of Guidance Documents for Embalming and Refrigeration

Ms. Yeatts explained that Guidance Documents 65-8 and 65-18 regarding permission to embalm and refrigeration of dead human bodies were no longer needed due to recent finalization of Board regulations on these issues.

Upon a *MOTION* by Mr. Slusser, and properly seconded by Mr. Jones, the Board voted to repeal Guidance Documents 65-8 and 65-18. The motion passed unanimously.

REVISIONS TO INSPECTION REPORTS AND APPENDIX I

Ms. Helmick discussed the revisions to the inspection reports for establishments and crematories and Appendix I of the Board's Regulations. She noted that the proposed changes to the Appendix correct the wording in two areas where the term "funeral establishment" should read as "funeral home" to ensure compliance with the relevant disclosure wording of the FTC regulations.

Upon a *MOTION* by Ms. Steele, which was properly seconded by Ms. Mimms, the Board voted to approve Appendix I as presented. The motion passed unanimously.

BOARD TRAINING

Mr. Walton approved Ms. Tillman Wolf's proposal to defer the presentation on Probable Cause to the next scheduled Board meeting due to time constraints.

Ms. Barrett provided a presentation on the Disciplinary Process.

NEXT MEETING

The next meeting date is April 16, 2019.

Virginia Board of Funeral Directors and Embalmers Full Board Meeting Guidance document: 65-4 Re-affirmed: January 24, 2019

Virginia Board of Funeral Directors and Embalmers

Aiding and Abetting Unlicensed Practice

Virginia Code § 54.1-2806(10) prohibits licensees of the Board of Funeral Directors and Embalmers ("Board") from "[a]iding or abetting an unlicensed person to practice within the funeral service profession[.]" All licensees of the Board are responsible for adhering to the laws and regulations governing the funeral service profession in Virginia.

If a licensee of the Board contracts to provide funeral services of any kind with another funeral director, funeral home, or entity providing funeral services, where the other contracting party is not licensed to practice within the funeral service profession, the licensee of the Board is in violation of Virginia Code § 54.1-2806(10) and may face disciplinary action. Specifically, the contracting party must be licensed in the state in which arrangements are or will be made.

Before entering into a business arrangement with another funeral director, funeral home, or entity providing funeral services, the Board recommends that Virginia licensed funeral service professionals verify the licensure status of the other party in the state in which arrangements are or will be made. Virginia licenses can be verified through the Department of Health Professions' license look-up feature, available at www.dhp.virginia.gov. Many other states have online license verification for funeral service professionals as well. As an alternative, a licensee may request that a potential contracting party provide the licensee with a copy of the contracting party's valid license.

The burden of ensuring that a licensee is compliant with the laws and regulations governing the practice of funeral services in Virginia rests solely with the licensee. Therefore, the Board recommends that licensees verify the licensure status of all parties with which they contract to provide funeral services.

BOARD OF FUNERAL DIRECTORS AND EMBALMERS

Guidance for Granting Internship Extensions

In accordance with **18VAC65-40-130**, the board, for good cause shown, may grant an extension of time for completion of an internship.

The board policy on granting an extension is as follows:

- The intern has to provide the board with a letter explaining the circumstances that have prevented the completion of the program within the specified time. The letter should include the length of time the intern is requesting for the extension. Additionally, the board will require a copy of the intern's current college transcript to review the courses already completed toward the mortuary educational requirement.
- The Board will grant no more than two one-year extensions to an intern.

Re: Funeral Service Licensees – Multi-Level License Options

Dear Dr. Brown:

I trust this letter finds you doing well. I am writing in follow-up to the conversation that you and I had during the 2019 Session of the Virginia General Assembly regarding a request to the Department of Health Professions (DHP) to provide an updated review of Multi-level Funeral Director licensees. I have enclosed correspondence dated October 15, 2015, on the work DHP had undertaken in response to a request from then, Senator Kenny Alexander.

In addition, Dr. Carter's workforce analysis, performed in 2018, revealed some telling information on workforce challenges involving Funeral Directors, either aging out or not pursuing the profession. Serval points of interest to note from the workforce report: 1) one-third of all licensees are over age 60; 2) non-renewal of licenses exceeded new licenses issued in 2018; 3) only 20% of licensees are under age 40; 4) 30% of Virginia licensees say they work more than 50 hours per week and 13% over 60 hours per week; 5) 8% of the workforce will retire within two years and 26% within ten years; and 6) retirements will begin to reach over 10% of the current workforce very five years by 2028.

We are seeing a number of workforce candidates who are near retirement or wish to work part-time. They may be interested in serving as a funeral service director but are not willing to perform embalming activities. Today these candidates are not eligible to be licensed in the Commonwealth. Conversely, we also have a number of candidates who are willing to embalm but are not interested in the other duties required of being a funeral director, such as family interaction and participating in funerals or memorial services.

We understand that our sister jurisdictions, namely, Maryland and North Carolina use a multi-level license process for funeral directors. In addition, we understand that Florida has a multi-level license process, as well. Understanding, operationally, how these states structure their multi-level license, would be beneficial.

One question that was brought up when multi-level licenses was initially discussed in 2013 centered on the accreditation of our current training programs at community colleges. Specifically, would changing to a multi-level license adversely impact accreditation. It would be beneficial to understand how training programs in our sister jurisdictions have navigated the accreditation requirements by honoring multi-level licenses. Also coupled with this would be an inquiry to determine portability of licenses, meaning that if someone were trained in Maryland and had a multi-level license, how they could relocate to Virginia or provide services here or vice versa.

During session we reached out to several different funeral establishments in the Commonwealth and there seemed to be a willingness to make this request of DHP and to participate in reviewing what information you have to present on multi-level licenses. We certainly view this alternative approach as a means to favorably address the workforce issues facing the Commonwealth.

Thank you in advance for your consideration and I will be more than happy to meet with you to discuss this further, or if you would like me to assist in identifying stakeholders to bring in and participate in this discussion, would be more than happy to do so.

This is in response to your request for the Department's assistance in studying options for separate funeral director-only and embalmer licenses. The review was assigned to the Board of Health Professions (BHP) due to its authority under §54.1-2510 of *Code of Virginia* to make recommendations on the need for regulation of health professions and to promote standards for their competency assessment. The following details BHP's findings and offers additional technical assistance from the Department.

Virginia issued separate licenses for Funeral Directors and for Embalmers until 1974 when a unified Funeral Service License was instituted. The separate categories of licenses were maintained because grandfathering permitted renewal of those licenses by existing holders. But since then, all *new* licensure candidates have had to demonstrate competence in the full array of funeral services, including embalming. At end of FY 2015, there were 1,422 Funeral Service Licensees (FSLs), 41 Funeral Director, and three Embalmer current, active licenses.¹

BHP conducted a review of all 50 states' statutes and regulations governing the funeral and embalming professions and the relevant public disciplinary information. A detailed overview is provided in Attachment 1, "States Licensure." Early on, it became clear that there is too much variability among the states on factors that could enable direct comparisons related to type of regulatory scheme possible. There are differing professional titles², practice scopes and standards, initial and continuing licensure requirements, and even the structure and processes employed by the overseeing regulatory bodies vary considerably from state-to-state.³

¹ Two of the Funeral Directors also held Embalmer licenses.

² Protected titles included "Embalmer," "Funeral Director," "Funeral Practitioner," "Funeral Service Provider" "Mortician" and "Undertaker," and several additional variations.

³ Some states regulate both Funeral Directors and Embalmers (or title variant), some regulate only one of these, and one state, Colorado, does not regulate either. Regulating organizations include licensing boards and agencies, health departments and, in California, a professional association.

Public disciplinary information was available in less than half of the states; the volume of cases per state was small and was reported in widely differing date ranges. What was available largely involved failing to obtain or maintain current licensure, insufficient continuing education, and a few cases of fraud related to contract arrangements. These referenced state-specific regulations that do not readily translate to other states. The Board concludes that it would not be reasonable to attribute differences in the prevalence of the states' disciplinary cases to differences in licensure scheme or any other factor.

BHP also gained independent insight into Virginian's views about multi-licensure to include a separate, new, funeral director only category. A public hearing was held on May 28, 2015 with additional written comment accepted until June 30, 2015. Attachment 2 summarizes the commenters' positions and also includes the complete public hearing transcript and all correspondence received. The responses were almost evenly divided in favor and against, with three commenters taking no position. Several pro and con themes emerged as follows:

With careful consideration of these findings, the Board concluded that there is insufficient empirically-based information and too evenly divided subjective viewpoints to substantiate their recommendation for or against a new license type. The Board's policy recommendations concerning the appropriate regulation of health professions rely heavily upon their standard evaluative methodology described in Attachment 3 *Policies and Procedures for the Evaluation of the Need to regulate Health Occupations and Professions.* In this case, the profession in question is already regulated by the Board of Funeral Directors and Embalmers for the public's protection either as a Funeral Director under grandfathering or subsumed under the unified Funeral Service License. Due to the tremendous variation in licensure schemes across the country and lack of consistently comparable disciplinary data, it is not possible to objectively determine whether the regulatory practices in other states are superior or inferior to Virginia's.

One of the chief points of contention is the perception that there is an insufficient number or distribution of Funeral Service Licensees in Virginia's workforce. Existing employment and licensure data, alone, cannot fully address this issue or whether the current embalming competency requirements unduly restrict the supply of practitioners. What is needed is objective data on the actual funeral practitioner workforce in Virginia.

As referenced in public comment, the DHP HWDC works to improve the data collection and measurement of the Commonwealth's healthcare workforce through regular assessment of workforce supply and demand issues among the multiple professions and over 370,000 practitioners licensed in Virginia through the Department. DHP HWDC surveys systematically glean key workforce-related data that detail the demographics, education, geographic distribution, full-time equivalencies, and other key variables to describe the licensees practicing in Virginia and their work settings. At the BHP's request, DHP HWDC staff is currently coordinating with the Board of Funeral Directors and Embalmers to develop and launch a new survey for renewing licensees. As with all DHP HWDC research, the results will be presented to the Board and published by the Department. Once instituted, the survey is administered with each year's renewals and will provide an ongoing, objective means to inform on the current funeral workforce environment and track trends over time. ⁵

The Department of Health Professions remains available as a resource with regard to this important workforce issues and to offer technical assistance in the preparation of legislative language if so desired.

UPDATE: We are receiving calls from members whose employees are very concerned about potential exposure and risk and seeking guidance for new policies or procedures. Here is new and updated information from the medical community indicating that the risk of exposure is "minimal":

The best defense is a good offense and I invite each of you to read and share the information we are sharing and discuss your current policies and procedures. I spoke with a reporter this week who has the medical beat. He indicated to me that radiopharmaceuticals are very promising treatments and will be more widely used into the future. Now is the perfect time to engage your employees in reviewing policies and procedures and training.

The recent study published in the *Journal of the American Medical Association* (*JAMA*) has captured everyone's attention. Radiation Contamination Following Cremation of a Deceased Patient Treated With a Radiopharmaceutical (link is to executive summary) brings to light potential exposure for staff who handle any of the nearly 40 million people treated with nuclear medicine each year.

In case you and your staff have questions about the safe handling of these cases, CANA has compiled the following resources to help you review your existing procedures and training.

Jeffrey Brunette, MS, CHP is a health physicist who works for the Mayo Clinic in Rochester, MN. Best Practice

CANA recommends asking all families for detailed medical information to properly understand and respond to potential risks. Just as you ask about the presence of pacemakers, ask about nuclear medicine treatments.

Paul Harris of Regulatory Support Services encourages all funeral home, crematory, and cemetery owners to ask the pertinent questions of their families. Cause of death is the first indicator that a case is at risk for radiation therapy, but all families should be asked in the case of death unrelated to their ailment. In many cases, families may be unaware or not understand the procedures the decedent has undergone. In these cases, you may need to ask for a Health Insurance Portability and Accountability Act (HIPAA) release form to contact the medical provider yourself. Asking the radiologist for information on the treatment

and about the specific isotope and its half-life is the best way to determine when (or if) it is safe to cremate or embalm the body. Depending on the isotope and when the treatment was administered, this could take weeks or even months.

As we learn more about this research and its implications I will share findings with you. I always welcome your questions, suggestions and feedback.

Board of Funeral Directors and Embalmers Report of 2019 Legislation

HB 1828 Sale of caskets; preneed arrangements for funeral services.

Chief patron: Orrock

Summary as passed House:

Funeral services; sale of caskets. Prohibits any person except a licensed funeral service establishment or funeral service licensee from offering for sale or selling a casket when preneed arrangements for funeral services are being made, including preneed funeral contracts and preneed funeral planning. The bill provides that the requirement that a funeral service licensee accept a casket provided by a third party applies only in cases in which funeral arrangements are made at-need. This bill is identical to SB 1247.

HB 2116 Disposition of the remains of a decedent; right to control.

Chief patron: Sickles Summary as introduced:

Disposition of the remains of a decedent; right to control. Establishes a priority order for the right to control the disposition of the remains of a decedent; the location, manner, and condition of disposition; and the arrangements for funeral goods and services to be provided, as well as circumstances that would forfeit this right. The bill establishes procedures for resolving disagreements among those who have the right to control and provides liability protections for licensed funeral establishments, funeral service licensees, registered crematories, or registered crematory operators that rely in good faith upon the instructions of an individual claiming the right of disposition.

02/05/19 House: Tabled in Health, Welfare and Institutions

HB 2445 Death certificates; medical certification, electronic filing.

Chief patron: Wilt

Summary as passed House:

Death certificates; medical certification; electronic filing. Requires the completed medical certification portion of a death certificate to be filed electronically with the State Registrar of Vital Records through the Electronic Death Registration System and provides that, except under certain circumstances, failure to file a medical certification of death electronically through the Electronic Death Registration System shall constitute grounds for disciplinary action by the Board of Medicine. The bill includes a delayed effective date of January 1, 2020, and a phased-in requirement for registration with the Electronic Death Registration System and electronic filing of medical certifications of death for various categories of health care providers. The bill directs the Department of Health to work with stakeholders to educate and encourage physicians, physician assistants, and nurse practitioners to timely register with and utilize the Electronic Death Registration System.

HB 2713 Death with Dignity Act; penalties.

Chief patron: Kory Summary as introduced:

Death with Dignity Act; penalties. Allows an adult who has been determined by an attending

physician and consulting physician to be suffering from a terminal condition to request medication for the purpose of ending his life in a humane and dignified manner. The bill requires that a patient's request for medication to end his life be given orally on two occasions and in writing, signed by the patient and two witnesses, and that the patient be given an express opportunity to rescind his request. The bill requires that before a patient is prescribed medication to end his life, the attending physician must (i) confirm that the patient is making an informed decision; (ii) refer the patient to a capacity reviewer if the physician is uncertain as to whether the patient is making an informed decision; (iii) refer the patient to a consulting physician for confirmation or rejection of the attending physician's diagnosis; and (iv) inform the patient that he may rescind the request at any time. The bill provides that neither a patient's request for medication to end his life in a humane and dignified manner nor his act of ingesting such medication shall have any effect upon a life, health, or accident insurance policy or an annuity contract. The bill makes it a Class 2 felony (a) to willfully and deliberately alter, forge, conceal, or destroy a patient's request, or rescission of request, for medication to end his life with the intent and effect of causing the patient's death or (b) to coerce, intimidate, or exert undue influence on a patient to request medication for the purpose of ending his life or to destroy the patient's rescission of such request with the intent and effect of causing the patient's death. Finally, the bill grants immunity from civil or criminal liability and professional disciplinary action to any person who complies with the provisions of the bill and allows health care providers to refuse to participate in the provision of medication to a patient for the purpose of ending the patient's life.

02/05/19 House: Left in Courts of Justice

SB 1247 Sale of caskets; preneed arrangements for funeral services.

Chief patron: Reeves

Summary as passed Senate:

Funeral services; sale of caskets. Prohibits any person except a licensed funeral service establishment or funeral service licensee from offering for sale or selling a casket when preneed arrangements for funeral services are being made, including preneed funeral contracts and preneed funeral planning. The bill provides that the requirement that a funeral service licensee accept a casket provided by a third party applies only in cases in which funeral arrangements are made at-need. This bill is identical to HB 1828.

SB 1300 Funeral establishments; full time manager requirement, exception, number of calls.

Chief patron: Edwards Summary as introduced:

Funeral establishments; full-time manager requirement; exception; number of calls.

Provides that the Board of Funeral Services may grant a hardship waiver from the requirement that each licensed funeral service establishment have a person licensed for the practice of funeral services or a licensed funeral director in charge, full time, allowing for the operation of two establishments by a single full-time funeral service licensee or funeral director if the combined average number of funeral calls at the two establishments over the previous three years is no more than 135 calls per year and the distance between the two establishments is 50 miles or less. Currently, the Board may grant the exception if the combined average number of annual calls at the two establishments is no more than 85 per year.

Chief patron: McClellan Summary as passed:

Death certificates; medical certification; electronic filing. 2. Please summarize the substance of the change you are requesting and state the rationale or purpose for the new or amended rule.

Under the sections shown in answers to question 3, the Board establish clear processes and guidance for the compelling disclosure of information when the Board or a Board investigation identifies potential (multiple?) class I misdemeanors occurring within a 36 month period. Such referral is not limited by Board action. Currently it appears that the Board does not make referrals for prosecution because of the stringency of the language found elsewhere in § 54.1-2400.2. Instead it seems that the Board solely relies on Monetary and licensing restriction or suspension. The Board should consider adopting language similar to the language in Maryland Title 10 DEPARTMENT OF HEALTH AND MENTAL HYGIENE, Subtitle 29 BOARD OF MORTICIANS AND FUNERAL DIRECTORS, Chapter 14 Compelling Purpose Disclosure. Additional guidelines should be established for such action and published. It could be part of or separate from the sanctioning manual.

10.29.14.02 Disclosure for Compelling Public Purpose.

The custodian may find that a compelling public purpose warrants disclosure of information in a licensing or investigative file, regardless of whether there has been a request for the information, and may disclose the information under the following circumstances:

10.29.14.01

.01 Scope.

A. This chapter permits the Board to disclose investigative information to other agencies, or other entities, or both, under certain circumstances.

B. A custodian may disclose information in a licensing or investigative file if the custodian determines that a compelling public purpose exists to warrant disclosure.

10.29.14.02

.02 Disclosure for Compelling Public Purpose.

The custodian may find that a compelling public purpose warrants disclosure of information in a licensing or investigative file, regardless of whether there has been a request for the information, and may disclose the information under the following circumstances:

- A. The information concerns possible criminal activity, and is disclosed to a federal, state, or local law enforcement or prosecutorial official or authority;
- B. The information concerns a possible violation of law, and is disclosed to a federal, state, or local authority that has jurisdiction over the individual whose conduct may be a violation, and the information disclosed is limited to information relevant to the possible violation by that individual; or
- C. The information concerns conduct by an individual which the Board reasonably believes may pose a risk to the public health, safety, or welfare, and is disclosed to a law enforcement authority, administrative official or agency that regulates the individual, or to a hospital or other health care facility where the individual has privileges.

Request for Guidelines to release Funeral Board Findings of multiple class 1 Misdemeanor vilations

Specifically, it appears that law provides a Board finding involving certain illegal activities which requires licensing action does not satisfy the penalty for a criminal act:

§ 18.2-7. Criminal act not to merge civil remedy.

The commission of a crime shall not stay or merge any civil remedy.

Virginia Board of Funeral Directors and Embalmers

Guidance on Surface Transportation & Removal Services

Virginia Code § 54.1-2819 requires the registration of persons or private businesses that engage in the business of surface transportation or removal of dead human bodies in the Commonwealth. This section further provides that:

Surface transportation and removal services shall not arrange or conduct funerals, provide for the care or preparation, including embalming, of dead human bodies, or sell or provide funeral-related goods and services without the issuance of a funeral service establishment license.

Where a registered surface transportation and removal service that is not otherwise licensed as a funeral service establishment contracts to provide transportation and removal services with a local governmental entity, the surface transportation and removal service may take the dead human body to a location or facility designated by the governmental entity, by a court order, or by the decedent's next of kin, guardian, or designated representative, but not to a location or facility chosen by the surface transportation and removal service. Further, the surface transportation and removal service may not store dead human bodies or arrange for storage of dead human bodies at locations or facilities not otherwise designated by the governmental entity, court order, decedent's next of kin, guardian, or designated representative.

Virginia Code § 54.1-2819 also provides that:

No licensed funeral service establishment shall be required to receive such registration in addition to its funeral service establishment license. However, such establishment shall be subject to the regulations pertaining to transportation and removal services.... [N]o person or private business shall engage in the business as a surface transportation and removal service without holding a valid registration.

Where an individual or private business independently contracts with a funeral establishment to provide surface transportation and removal services, the individual or business is required to be registered with the Board as a surface transportation and removal service.
