#### **NEW BUSINESS**

# Virginia Performs

Sandra Ryals, Director of DHP provided a report of the agency and its Key Performance Measures as mandated by Governor Kaine. Please see the attached handout. Mrs. Ryals shared that the measurers examine standard of care cases which exempts the majority of cases of the Board of Funeral Directors and Embalmers. Yet, the Board must continue to adhere to agency standards for the timely adjudication of disciplinary cases. The shortfall will affect hiring and travel primarily in the agency.

# Virginia Board of Funeral Directors and Embalmers Board Meeting August 28, 2007

## **Designation of Subordinate(s)**

The Board will meet with the Board's Subordinate, Michael Williams, at its December 2007 Meeting. The will go into executive session. Some members of the Board expressed concerns of the increasing numbers of subordinate cases.

Mr. Nelsen made a motion to extend the current term of the agency subordinate until the December 2007 meeting. The motion was properly seconded by Mr. Leonard. The motion carried unanimously.

## **Mortuary Science Programs offering study session for State Examination**

The Board discussed a need for the state's Mortuary Science Programs to offer study courses for the jurisprudence exam. On June 21, 2007, Ms. Young met with Rhonda Pleasants of John Tyler Community College and Frank Walton of Tidewater Community College. The group discussed the establishment of jurisprudence study courses, a need to issue a RFP for an organization to provide study courses, the need for experts in writing test questions, to increase the number of test questions from 50-75 or 100. Also, the group discussed the funeral director license. From the meeting, the Board suggested that no current program directors serve as examination experts. It is seen as a conflict of interest if they offer the study courses and provide questions as experts. The Board directed the Examination Committee to meet within the next two months.

#### **American Board of Funeral Service Education**

The American Board of Funeral Service Education will take comments until November about Funeral Service Arts associate Degree Program. The Board wishes not to render any comments at this time.

#### **Continuing Education Committee**

Ms. Young stated that there is a difference in the calculation of hours for the Academy of Professional Funeral Service Practice. Ms. Hughes made a motion for the Board not to accept their approvals. The motion was properly seconded by Mr. Ball. The motion carried unanimously.

# **Inspection Guidance Document**

This document will be presented at the meeting of the Task Force on Inspections scheduled for October 16, 2007.

# **International Conference of Funeral Service Examining Boards**

The International Conference of Funeral Service Examining Boards information refers to the Board passing rate. The Annual Conference is scheduled for the last week of February 2008. Ms. Hughes shared that it is the responsibility of the mortuary schools to provide study courses for the national examination.

## **Cemetery Board**

The minutes of the Cemetery Board were provided for the Board's review.

# **Funeral Article-Disposition of unidentified remains**

Dr. Marcella F. Fierro sent a memorandum to Ms. Elaine Yeatts regarding crematory regulations and the disposition of unidentified remains. Dr. Fierro stated that in her opinion unidentified bodies should not be cremated because of a possible pending court case. She also thinks that their needs to be accountability for the unidentified remains since there are more than 14,000 unidentified remains in the United States. Dr. Fierro, or her successor after December 31, 2007, would be willing to work with the Funeral Board to develop regulations on the cremation of unidentified bodies. The majority of the Board believes that the bodies should stay at the Medical Examiner's office until identified.

#### **OLD BUSINESS**

#### Legislative/Regulatory Committee

The Adoption of proposed general regulations will occur at the Board Meeting on October 16, 2007. Dr. Marcella Fierro provided comments regarding crematory regulations under the disposition of unidentified remains. The meeting date for the Legislative/Regulatory Committee is November 13, 2007.

Ms. Hughes stated that the PBS television show <u>Front Line</u> will discuss the funeral industry on October 30, 2007.

# Report of the Initial and Renewal Applications of Waiver Of Full-Time Manager Requirements

Ms. Young provided the Board the quarterly report of Waiver of Full-Time Manager Requirements as of August 13, 2007.

# **Executive Director's Report**

Licensee Statistics and Disciplinary Statistics were reviewed from the Agenda packet. Ms. Young provided to the Board information on the budget and the fact that there is only \$4,024 in its budget as of June 30, 2007. A report on finance projections and a financial analysis will be presented at the December 2007 Board meeting for a possible fee increase. Ms. Young presented the calendar for the rest of the 2007 year.
