POLL OF MEMBERS:

Dr. Seeman polled each Board member as to whether they could have attended a regular meeting at the offices of the Board of Counseling, in a timely manner for the purpose of hearing evidence in a possible summary suspension case. Each Board member polled stated that they would not have been able to attend.

With eleven Board members participating and three members unable to participate, it was established that a quorum could not have been convened in a regular meeting to consider these matters.

THERESA ZODY, CSAC Certificate No. 0710-000532 Mr. Schliessman presented a summary of the evidence in the case.

Decision:

Mr. Turner moved, that with the evidence presented, the practice as a certified substance abuse counselor by Theresa Zody, posed a substantial danger to the public; and therefore, that the certificate of Theresa Zody, to practice as a certified substance abuse counselor, be summarily suspended. The motion was seconded by Ms. Argow. The Board voted 11-0 in favor of the motion.

Ms. Argow moved that a Consent Order be offered to Ms. Zody for the indefinite suspension, for not less than one year, of her license in lieu of a hearing. The motion was seconded by Mr. Haber. The Board voted 11-0 in favor of the motion.
