Ms. Ellers was represented by Marjorie L. Wall, Esquire. The Board received evidence and

sworn testimony in the matter.

The proceedings were recorded by a certified court reporter.

CLOSED SESSION: Upon a motion by Sandra Malawer and duly seconded by Mary Lou Argow,

the Board voted 5-0 to convene a closed meeting pursuant to § 2.2-3711(A)(27) of the Code of Virginia for the purpose of deliberation to reach a decision in the matter of Mary Ellers. Additionally, she moved that Mr. Casway, Ms. Brown, Ms. Larimer and Ms. Pollick attend the closed meeting because their presence in the closed meeting was deemed necessary and would

aid the Board in its deliberations.

RECONVENE:	Having certified that the matters discussed in the preceding closed session met the requirements of §2.2-3712 of the Code of Virginia the Board reconvened in open session.	
DECISION:	Upon a motion by Mary Lou Argow and duly seconded by Vivian Sanchez- Jones, the Board voted 5-0, to accept the Findings of Fact and Conclusions of Law as read by Mr. Casway.	
	William Scott moved to accept the Board's decision as read by Howard Casway, which was to affirm the Credentials Committee's determination that Ms. Ellers did not meet the minimum degree requirements of 18 VAC 155-20-49(B) of the Regulations Governing the Practice of Counseling and that she is not approved to proceed with supervision towards licensure as a Licensed Professional Counselor. The motion passed unanimously.
