Ms. Yeatts explained the need to promulgate regulations as mandated by law in reference to occupational therapy assistants. Ms Cooper moved to recommend language for the regulations. The motion was seconded and approved.

He mentioned that fewer applicants were examined last year, and that suggestions were given for taking the examination.
