The Committee fully discussed with Mr. Cleveland the allegations as outlined in the Notice, specifically, Mr. Cleveland may have violated 18 VAC 95-20-470(1) and (2) of the Regulations Governing the Practice of Nursing Home Administrators during his course of employment at Norfolk Health Care, Norfolk, Virginia ("Norfolk Health Care")*:

On the basis of the Findings of Fact and Conclusions of Law, the Committee ORDERED the follows:

- 1. Prior to March 31, 2009, Mr. Cleveland shall submit written proof of completion of 24 hours of Board-approved courses in the area of leadership, specifically in the areas of coaching and motivating, and 40 hours of Board-approved courses in the areas of ethics and/or legal liability for nursing home administrators. The courses shall be submitted to the Board for prior approval, and shall consist of classroom hours, and not internet or self-study hours. Proof of completion shall be submitted within ten days of course completion.
- 2. Mr. Cleveland shall maintain a course of conduct in his capacity as a nursing home administrator commensurate with the requirements of § 54.1-3100 *et seq.* of the Code and the Regulations Governing the Practice of Nursing Home Administrators.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of the Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.

Upon a motion by Ms. Fletcher and duly seconded, the decision of the Committee was adopted. The vote was unanimous in favor of the motion.
