CALLED TO ORDER

Ms. Yeatts called the public hearing to order at 10:50 a.m.

Ms. Yeatts stated that this was a pubic hearing to receive comments on amendments to the Board of Long-Term Care Administrators regulations; specifically, to allow up to ten (10) hours of continuing education in Internet or self-study courses and to eliminate the state jurisprudence examination for nursing home administrators. Ms. Yeatts provided copies of the fast-track regulations for the public.

PUBLIC COMMENT PERIOD

Mr. Yeatts called the first commentor for public comment.

Beverley Soble, Vice President Regulatory Affairs, with the Virginia Health Care Association (VHCA), stated that she supports the continuing education amendments and the elimination of the state jurisprudence examination. Ms. Soble suggested that the Board investigate the use of audio conferences, web-inars, and web-x, on how they will be classified with the National Association of Long-Term Care Administrator Boards (NAB); whether they will be considered distant learning or face-to-face. further stated that the Board had the great foresight for consideration of these amendments to the continuing education, in light of the energy crisis and the need to obtain credits by an alter means.

Ms. Soble also asked the Board to provide clarification of the ten (10) hours nursing home administrators are allowed to carry; if there will be a distinction of what 'type' of hours will be allowed to carry. Currently the regulations do not specify.
