FINAL MINUTES

Board of Agriculture and Consumer Services Holiday Inn of Harrisonburg, Harrisonburg, Virginia August 24, 2006

The meeting convened at 2:00 p.m. on Thursday, August 24, 2006, in the Jefferson/Madison Room of the Holiday Inn of Harrisonburg at 1400 East Market Street in Harrisonburg, Virginia. APPROVAL OF MINUTES

The minutes of the May 18, 2006 meeting were approved as presented.

REPORT FROM BOARD MEMBERS

Gregory Galligan reported that Northern Virginia has had a lot of rain, which has caused flooding in the Alexandria area. The flooding has caused some people to be displaced. FEMA and the Small Business Administration will be offering loans for individuals who have been affected by the flooding. He noted that donations were being received to help those impacted by the flooding.

Mr. Brian Calhoun reported that Dr. Mark McCann has been appointed as Associate Dean and Director of Cooperative Extension. He mentioned that Dr. Karen Byrd have been hired as the Associate Director for Family and Consumer Sciences and Mr. Ray Alley joined the administrative team on July 5, 2006 as Director of Field Operations. They are expecting to have 20+ extension agent positions advertised in September as a result of a critical staffing initiative that was funded this year. He noted that classes at Virginia Tech have begun.

Mr. Hardesty thanked Andrea Lohr for hosting the board meeting and tour this year. He gave a report that the crop production will be down for some commodities. He noted that the dry weather has impacted crops and pastures. He mentioned that a national fruit processing plant, which has been an apple processing plant for over a 100 years in Winchester, were sold to one of the employees and a group of other investors.

Mr. Fleming reported that the conditions of winter wheat and barley are good but the hay crop is not. He noted that dry weather is impacting the crops. He reported that a new extension agent for Goochland and Powhatan has been appointed.

Mr. Rogers reported that the peanut crop this year will be smaller than last year's. He noted that more reductions are expected next year. He also emphasized the impact of dry weather on agriculture.

Ms. Lohr welcomed the Board to the Shenandoah Valley and indicated that she was pleased to host the Board. She reported that the area has not had any rain in six weeks and that the entire district is very dry. She added that those persons raising produce in the area are reporting problems with the dry weather. Things are becoming critical.

Mr. Holland reported that rain has been spotty on the Eastern Shore with precipitation ranging from one inch to 10 inches in some places. He indicated that this year's corn crop had the potential for being the largest ever, but that the dry weather has reduced that potential. He added that the corn crop is still going to be good. He mentioned that investors from a neighboring state in Maryland will be coming to the Eastern Shore to discuss building a 2m gallon per year ethanol plant.

Ms. McDowell reported that Southside Virginia was dry, adding that the tobacco crops are not good. She pointed out that the cost of fuel is affecting farming. She noted that high energy costs have caused farmers to delay use of their irrigation equipment. She reported that the price of cattle continues to be stable.

Mr. Moore - reported that Virginia State University began classes on August 21, 2006. He also reported that he is now the chair of the 1890 Universities association. He noted that the Secretary of Agriculture is scheduled to meet with Mr. Moore at Virginia State

on September 5. He also reported that the University has added a new terminal degree to its program. In closing, he thanked the Board members for their letters of card and condolences.

Kevin Barnes, Director, Virginia Agricultural Statistics Service, briefed the Board on production reports, releases, and studies made by his office.

NEW BUSINESS

President Holland reported that Secretary Robert Bloxom sends his regrets for not being able to attend the Board meeting because of the Governor's Cabinet meeting.

Commissioner Courter provided information to the board on a letter from Old Dominion Grain regarding grain inspection services provided by VDACS. The Commissioner and Tom Sleight, Director of Marketing, together reviewed with the Board the Department's on-going efforts to attract new persons to be licensed inspectors.

Mr. Galligan initiated a discussion of what can be done to make Board members more accessible to the persons living in their Congressional districts. One idea was to create an electronic bulletin board where the public could post questions/comments. Mr. Galligan asked that the Board be given some options to consider at a future meeting and suggested that each Board member could choose to opt-out if he or she is not interested in being more accessible to the public. During the discussion of communications with the public, Mr. Moore suggested that Jasen Eige brief the Board at a future meeting regarding the role of the individual Board members versus the role of the Board as a group. Mr. Eige agreed to do this at a future meeting.

Ms. McDowell reported that she had received a letter from a person who opposes the use of gas chambers in euthanizing animals. Dr. Richard Wilkes, State Veterinarian and Director of the Division of Animal and Food Industry Services, briefed the Board on the issues relating to the use of gas chambers, noting that the American Veterinary Medical Association continues to recognize it as an acceptable form of euthanasia for pounds and shelters.
