Report of the Housing

Committee

Ms. Nancy O'Brien, Chairman of the Housing Committee,

reported on the morning meeting of the Committee. Ms. O'Brien reported on issues under consideration in the development of the private activity bond guidelines. Ms. O'Brien stated that a report on the 2008 CAPER would be reviewed by the Committee at the

next meeting.

Regulatory Update

Mr. Emory Rodgers, Deputy Director of the Division of Building

and Fire Regulation, provided an update on code training. Mr.

Rodgers also reported on the recent ICC hearings and the issues

the Board will consider when adopting the 2009 codes. Mr. Bill Shelton, Director of the Department of Housing and Community Development, reported on meeting with members of the Virginia Fire Services Board in Hampton during the Governor's Housing Conference.

Public Participation Guidelines Mr. Calhoun provided an overview of the legislative background for the development of model public participation guidelines. Mr. Calhoun reviewed the provisions of the current guidelines and those of the model guidelines. A motion was made to adopt the model public participation guidelines. The motion was seconded and unanimously passed.

Virginia Housing Partnership Fund Mr. Shelton provided an overview of the Virginia Housing Partnership Fund (the "Fund") and the reporting requirements for the Fund. Ms. Susan Dewey, Executive Director of the Virginia Housing Development Authority and Mr. Art Bowen, Managing Director of Finance and Administration at VHDA, presented and reviewed the financial statements for the Fund. Mr. Bowen also presented financial statements for the Commonwealth Priority Housing Fund. A motion was made by Mr. Anthony Clatterbuck for the Board to accept the financial report on the Fund with staff reviewing the audited financial statements, when available, to assure there are no changes to the statements presented. The motion was seconded and passed. Ms Dewey abstained from voting.

VHDA Report

Ms. Dewey reported on the tax exempt bond market, the work of the Foreclosure Prevention Task Force and recent federal legislation.

Report of the Director

Mr. Shelton reported on state budget issues, the HOME accessibility study, neighborhood stabilization and other provisions of the federal Housing and Economic Recovery Act of 2008. Mr. Shelton also provided an update on the work and upcoming meetings of the Virginia Housing Commission and the Southwest Virginia Cultural Heritage Commission. Mr. Shelton provided an update on the DHCD building status and reports on recent grant announcements and awards.
