Codes and Standards Committee

Mr. Anthony Clatterbuck, Chairman of the Codes and Standards Committee, reported the Committee met on June 22, 2009 and prior to the full Board meeting today. Mr. Clatterbuck reported that the Committee recommended the Board adopt proposed 2009 amendments for the Manufactured Home Safety Regulations, the Virginia Certification Standards, the Industrialized Building Code Regulations, the Amusement Device Regulations, the Statewide Fire Prevention Code and the Uniform Statewide Building Code as presented in the Board meeting workbook. The committee recommendation passed on a 9-2 vote, Mr. Michael Reilly and Ms. Saulnier voting against the recommendation. The Committee requested and the Board approved requesting that work groups of interested parties continue to consider issues and possible alternatives, options, trade-offs and compromises related to residential fire sprinklers.

Ms. Susan Dewey, Executive Director of Virginia Housing Development Authority (VHDA) spoke about the Virginia Housing Center and provided and update on the federal Low Income Housing Tax Credit Program.
