Report of the Codes and Standards Committee: Adoption of Regulations Mr. Clatterbuck, Chairman of the Codes and Standard Committee, reported on the morning meeting of the Committee. Mr. Clatterbuck reported that the Committee had completed its consideration of building and fire code regulations and was ready to make recommendations to the full Board. Committee recommendations are to adopt the 2009 editions of the ICC codes

with modifications and amendments as specified. Each 2009 code is voted on separately.

Mr. Clatterbuck reported that the Committee recommended the adoption of amendments to the Uniform Statewide Building Code, Parts I, II and III, as modified by the Committee. A motion was made to adopt the amendments to the regulation as modified by the Committee. The motion was seconded and unanimously passed.

Mr. Clatterbuck reported that the Committee recommended the adoption of amendments to the Statewide Fire Prevention Code. A motion was made to adopt the amendments to the regulation as recommended by the Committee. The motion was seconded and unanimously passed.

Mr. Clatterbuck reported that the Committee recommended the adoption of amendments to the Virginia Amusement Device Regulations. A motion was made to adopt the amendments to the regulation as recommended by the Committee. The motion was seconded and unanimously passed.
