Report of the Codes and

Standards Committee

Mr. Clatterbuck, Chairman of the Codes and Standards Committee, reported on the morning meeting of the Committee. Mr. Clatterbuck reported that the Committee discussed additional regulations to be considered for amendment during the current regulatory amendment cycle. The regulations discussed were the Manufactured Home Safety Regulations, the Virginia Certification Standards and the Standards Governing the Operation of Individual and Regional Code Academies. Mr. Clatterbuck reported that the Committee recommended initiating a NOIRA for the *Manufactured Home Safety Regulations*. The Committee recommendation was unanimously approved by the Board. Mr. Clatterbuck reported that the Committee recommended initiating a NOIRA for the *Virginia Certification Standards*. The Committee recommendation was unanimously approved by the Board. Mr.

Clatterbuck reported that the Committee recommended initiating a NOIRA for the *Standards Governing the Operation of Individual and Regional Code Academies*. The Committee recommendation was approved by the Board, Mr. Munoz voting against the recommendation.

Mr. Clatterbuck reported that there had been no public comment received regarding the periodic review of the Solar Energy Criteria for Tax Credit Regulation. Staff also had no recommendations for amending this regulation. A motion was made to retain the current regulation with no amendments. The motion was seconded and approved by the Board, Mr. Munoz voting against the motion.

Mr. Clatterbuck reported that the Board's proposed Memorandum of Agreement (MOA) between the Board of Housing and Community Development and the Virginia Fire Services Board has been approved by the Virginia Fire Services Board. The final MOA would be signed by the chairmen of the Boards following the Board meeting.

Virginia Housing Partnership Fund Mr. Bill Shelton provided an overview of the Virginia Housing Partnership Revolving Fund (the "Fund") and the reporting requirements for the Fund. Ms. Melody Barackman, Controller of the Virginia Housing Development Authority (VHDA) presented and reviewed the financial statements for the Fund. Ms. Barackman also presented financial statements for the Commonwealth Priority Housing Fund. A motion was made for the Board to approve the financial report for the Fund. The motion was seconded and unanimously passed.

VHDA Report

Mr. Bill Shelton, Director of the Department of Housing and Community Development, provided a report on the recent meeting of the VHDA Board of Commissioners. Mr. Shelton reported on the Low-Income Housing Tax Credit Program and Private Activity Bonds.

VFSB Report

Ms. Elaine Gall reported on the recent VFSB meeting in Hampton, Virginia. Ms. Gall also reported on ATL, VFIRS, fire deaths and injuries, the MOA between the BHCD and the VFSB. The next meeting of the VFSB will be in November in Richmond.

Mr. Shelton reported on the state housing trust fund, the Virginia Housing Commission, 2013 agency legislation, the Housing Policy Workgroup and Advisory Committee, the DOJ settlement housing plan, recent CDBG awards, and the upcoming Governor's Housing
