Approval of Minutes A motion was made to approve the minutes of the December 16,

Executive Order Number 2 Mr. Bill Shelton, Director of the Department of Housing and

Community Development, provided an overview of the Governor's Executive Order Number 2 regarding the receipt of certain gifts. Mr. Shelton reported that additional information and training on the Executive Order would be provided following the

appointment of the Executive Branch Ethics Commission.

USBC – Wall Bracing Mr. Emory Rodgers, Deputy Director of the Building and Fire

Regulation Division of the Department reviewed provisions adopted by the Board in December regarding requirements for wall bracing in townhomes. Mr. Rodgers reported that building officials and home builders have reported that the new Section R602.12.3.1 townhouse provisions conflict with other provisions of the USBC.

A motion was made to delete Section R602.12.3.1. The motion was seconded and unanimously approved.

2012 Regulatory Adoption Overview Mr. Rodgers presented a general overview of the process and issues considered by the Board during the last two years in the development of the 2012 Uniform Statewide Building Code, Statewide Fire Prevention Code and other related regulations.

Consolidated Plan

Mr. Chris Thompson, Deputy Director of the Division of Housing, provided an overview of the process for developing this year's Action Plan for HUD setting out the use of federal funds for housing and community development purposes. Mr. Thompson reported on components of the Plan and housing needs and community development needs in Virginia. Mr. Thompson reported on programs used to address these needs and upcoming input sessions to be held by the department to better define Virginia's needs. The Board will be presented a proposed Action Plan for consideration and approval during the May 19, 2014 Board meeting.

VHDA Report

Ms. Susan Dewey, Executive Director of the Virginia Housing Development Authority, reported on federal secondary mortgage market reform. Ms. Dewey also reported on federal tax reform that may impact the low income housing tax credit program and private activity bond financing.

VFSB Report

Mr. John Ainslie reported on the recent VFSB meeting. Mr. Ainslie reported on Fire and EMS studies, burn building grants, the Governor's Fire Services awards and the annual Fallen Fire Fighter memorial to be held in Richmond on June 7.

Report of the Director

Mr. Bill Shelton, Director of the Department of Housing and Community Development, reported on budget matters currently being considered by the General Assembly. Mr. Bill Ernst of the Department's Policy Office presented and overview of legislation from the 2014 legislative session. Mr. Shelton reported on the upcoming Building Safety Month event to be held 6th in Richmond on May 6, 2014. Mr. Calhoun presented an update on regulations adopted by the Board, including the scheduled publication and effective date of the regulations. Mr. Rodgers provided an update on training to be provided on the new regulations.
