Approval of Minutes

A motion was made to approve the minutes of the March 24, 2014

meeting of the Board. The motion was seconded and unanimously

passed.

Report of the Joint Meeting of the Housing Committee and the Community Development Committee Mr. Jim Hyland, Chairman of the Housing Committee, reported on the joint meeting of the Housing Committee and the Community Development Committee. The committees reviewed the proposed 2014-2015 Consolidated Plan Action Plan to be presented to HUD that was prepared by DHCD staff. The joint committee recommended its approval. A motion was made on the Committee recommendation for approval of the Action Plan and the motion

was unanimously passed.

Report of the Codes and Standards Committee

Mr. Anthony Clatterbuck, Chairman of the Codes and Standards Committee, reported on the morning meeting of the Committee. Mr. Clatterbuck reported that the Committee discussed problems and concerns with provisions on fire safety of floors contained in the 2012 International Residential Code that had been adopted by reference into the final Uniform Statewide Building Code (USBC).

## Board of Housing and Community Development May 19, 2014

Following a discussion of the building and enforcement issues, a motion was made to suspend and readopt the USBC and remove the adoption by reference of the International Residential Code Section R501.3 from the final USBC and for the readopted regulation to be scheduled to become effective on July 14, 2014. The motion was seconded and unanimously approved.

Suspension of Regulations on Fireworks Issue

Mr. Emory Rodgers, Deputy Director of the Division of Building and Fire Regulation, reported that provisions in the Statewide Fire Prevention Code and the Uniform Statewide Building Code related to the storage of "permissible" fireworks had been suspended for additional public comment and Board consideration. The Board is scheduled to take final action on the issue at its July 28, 2014 meeting.

VHDA Report

Mr. Bill Shelton, Director of the Department of Housing and Community Development (and VHDA Board of Commissioners member), reported on the recent VHDA Board retreat, bonds, and REACH *Virginia* (Resources Enabling Affordable Community Housing in Virginia) administered by VHDA.

VFSB Report

Mr. John Ainslie reported on the next meeting of the VFSB in June and reported on the new Director of the Department of Fire Programs. Mr. Ainslie spoke about the upcoming Fallen Fire Fighter Memorial service to be held in Richmond during June.

Report of the Director

Mr. Shelton reported on the current status of the state budget, the recent HUD 811 Program application submitted, the workshop on homeless veterans to be held in Richmond on June 9, 2014, Building Safety Month and recent announcements for the Virginia Main Street Program.
