Committee

Ms. Davis asked Ms. Shea Hollifield, Deputy Director of the Division of Community Development, to provide an overview of the meeting of the Community Development Committee and the proposed amendment to the Enterprise Zone Grant Program Emergency Regulation. The proposed amendment would define the term "business firm" as "any corporation, partnership, electing small business (subchapter S) corporation, limited liability company, or sole proprietorship authorized to do business in the Commonwealth of Virginia as well as business and professional organizations and associations classification falls under sectors 813910 and 813920 of the September 14, 2005

North American Industry Classification Systems (NAICS)." A motion was made to approve the proposed amendment. The motion was seconded and unanimously passed.

VHDA Report

Ms. Susan Dewey, Executive Director of the Virginia Housing Development Authority (VHDA), and Mr. Art Bowen, Managing Director of Finance for VHDA, presented financial data on the Virginia Housing Partnership Fund and the Commonwealth Priority Housing Fund. Mr. Bowen reviewed financial schedules for these funds. A copy of the unaudited financial report was provided. Mr. Bowen stated that the audited version of these statements would be available in October.

Virginia Fire Services Board Report Mr. Brian Mullins reported on fiscal year 2005 income and that additional funds available are being used for training and larger grants to localities for fire services.
