# **Virginia Retirement System**

- Whether universities that did not opted out plan were secure in their investment.
- The goals of VRS workshops and types such as investments, retirement and other.
- How can an agency get VRS to give a presentation at their location and what are the criteria's.

# **State Retiree Health Benefits Program**

Mary Habel gave a brief overview on the state retiree health benefits program/Medicare eligible plans. She distributed the monthly premium rates for FY2004 rates will go into effective January 1, 2004. Mary Habel also explained the health insurance credit.
