#### **Call to Order:**

Linda LaMona, Vice-Chair, called the meeting to order at 9:30 AM and asked that all present to introduce themselves starting with the Committee members.

#### **Draft Minutes Review and Approval:**

### <u>Division of Rehabilitative Services Director's Report:</u> <u>Sub-Committee Reports:</u>

Ms. Hayfield explained the current status of the agency's Order of Selection for vocational rehabilitation services. In March of 2011, the Division of Rehabilitative Services (DRS) was forced to close all disability categories due to lack of sufficient case service funds. Eligible individuals were placed on a waiting list. DRS began to take people off this waiting list on November 1, 2011, as funds were available. Following an infusion of monies from the Governor and Virginia General Assembly, DRS was able to serve all clients who were most significantly disabled (MSD) beginning on June 1, 2012. A total of 6,461 most significantly disabled clients who had been placed on the DRS waiting list were notified. As of October 12, 2012, seventy eight percent (5,030) clients had returned to DRS for services. Of those clients moved into

service from the MSD waiting list, 294 have become successfully employed representing a 56.2% rehabilitation rate for this cohort. While no clients with most significant disabilities now remain on the waiting list, another 1,580 clients are awaiting services from the Division of Rehabilitative Services.

At the current rate of authorization and anticipated expenditures, DRS would over expend our allocated case service dollars by year's end; therefore, closure of the MSD category is necessary. DRS will close the MSD category on November 15, 2012. We will strategically bring consumers off of the waiting list in the coming months based on availability of funding.

Counselors will continue to encourage applications. We will remove people from the waiting list based on application date as funds allow. We do not expect to have people on the waiting list for extended periods of time.

Kathy Hayfield also reported that the General Assembly report for LTESS was submitted and is now available. The report contained the LTESS statistics which were reviewed at the July 2012 ESOSC meeting. The report can be found at

#### **Funding Sub-Committee:**

Chuck McElroy, subcommittee chair, reported that the funding subcommittee had not met but is scheduling a face to face to meeting in Roanoke area in November. Committee Members should expect an email with dates.

The committee plans to review several factors related to the LTESS system; the effectiveness of the three year rolling average and the 70 hour of work requirement. Chuck asked that committee members who have suggestions or ideas for items send them to him.

#### **GWU TACE Center Update**

Rob Froehlich updated the committee regarding the GWU TACE ACRE Training Series. In face to face training were held in Winchester, VA, Annapolis, MD and Norfolk, VA. A new online component has begun and a second online cohort will star early next year.

GWU participated in both the Collaborations Conference and the Employment First summit. Joan Kester presented at the Employment First summit. The TACE center is ready to kick off a series of webinars soon. The first one will focus on "Working with Challenging People". More information will be coming shortly.

#### **AT Training for ESOs**

Alisha Louther and Barclay Shepard of the Virginia Assistive Technology System (VATS) discussed AT training that is available to ESOs. The 1 hour training helps staff better understand AT Services and resources available to their consumers. An information flyer is attached. The focus of the training is AT@Work.

#### **Project SEARCH end of Year Review**

Donna Bonessi reviewed stats for the 2011-2012 School year for Project SEARCH.

- DARS was a partner in 10 Project SEARCH programs.
- 78 students began the program in September 2011
- 89.7% (70) Students completed the program
- 62% (44) of students were employed as of 7/31/12
- 31% (22) of students who **completed the program** are employed in the host company (National average is 25%)
- \$9.22 is the average hourly wage for students. (Norfolk has the highest average hourly wages at \$11.49)
- 28.19 are the average hours worked per week. (Hampton has the highest average hours worked at 32.5)
- 1212 is the average number of job coaching hours per site provided by ESOs this school year.

#### ESO Report card-

Barbara Burkett answered questions regarding the ESO report card data and offered to review each organization's data with them upon request. Input from members -- the *removal from benefits* category is hard to define and aggregate since many people stop receiving benefits many months after case closure. This data is not accurate and will not be able to be accurately calculated using AWARE. Dr. Burkett agreed to take another look at this element.

#### LTESS/EES Business:

Judy Hill announced that the EES system has been updated to allow for hourly billing within the EES system without merging the two funding categories. ESOs now have the ability to use EES funds for individual supported employment. She explained that one organization has already begun to utilize EES funds to support a consumer in an individual supported employment job.

Judy Hill recommended that ESOs review LTESS/EES System reports for their organizations that are available to them. One example is: "Expected Actual"- this report shows where your expenditures should be, consistent with the year to date actual billing.
