#### **Call to Order and Introductions**

Catherine Harrison facilitated the meeting, calling the meeting to order at 1:05 p.m. and introductions were made by each member. Motion was made by Courtney Tierney and seconded by Jane Ward Solomon to accept the minutes of the September 8, 2011 Team meeting.

#### **Role of the Implementation Team**

Catherine Harrison gave an overview of the role of the Implementation Team:

- Its relationship to and with the Advisory Commission.
- The importance of Olmstead and Virginias obligation
- The charge of the Executive Directive 6 to agencies to annually update the strategic plan (August 31) for community integration of Virginians with disabilities
- The goals of the strategic plan
- The role and the purpose of the Advisory Commission

#### Moving Forward/ Process Improvement Discussion

Catherine Harrison opened the floor to each team member for discussion on past issues:

- A joint Advisory Commission/ Implementation Team meeting once yearly
- Regular attendance is critical by same person
- Funding for programs
- Scope and lack of focus
- What is the end goal?
- Improve working relationship with the Advisory Commission
- Redo Strategic Plan in its entirety
- Confusion as to which group does what

#### **Strategic Plan**

A lengthy discussion on the status of the current Strategic Plan and the need to rewrite the document occurred. The Implementation Team indicated that the plan is outdated and cumbersome. The focus of the new plan should be on housing, support services and employment/social integration into the community. Terry Smith made a motion to approve the current plan as an interim document with an amendment to redo the plan in 2012; second by Theresa Preda.

#### **Department of Justice Update**

Kristin Burhop updated the Team, stating that the agreement is not yet resolved but is about 90% complete. They hope to finalize the agreement in the next couple of weeks. Once the settlement agreement is in place an operational plan will be put in place.

## **DBHDS** Community Integration Efforts

#### (Heidi Dix, Assistant Commissioner DBHDS)

- \$30 million trust fund was created by the General Assembly to transition individuals from training centers into the community.
- 60 individuals to transition into community from SVTC and CVTC by June 30, 2012
- \$3000 start-up funding for residential service providers
- \$1000 for day support providers

## New State Agency (Commissioner Jim Rothrock, DRS)

Commissioner Rothrock talked about the new Agency which will be more efficient and effective The new agency will include all functions of DRS, VDDHH, and VDA by July 2012. In 2013 adult protective services and adult services from DSS will be integrated. Legislation is in process. Monetary savings are not anticipated but administrative efficiencies and better service provision are expected.
